KNOW ALL MEN BY THESE PRESENTS

THAT, WHEREAS, heretofore, on to-wit, April 3, 2001, Maria C. Palacio, an unmarried woman, executed a certain mortgage on property hereinafter described Green Tree Servicing LLC successor servicer to Greenpoint Credit Corp., which mortgage is recorded in Instrument Number 2001-14926 in the Office of the Probate Judge in Shelby County, Alabama; and

WHEREAS, on the 15th day of November, 2010, the day on which said foreclosure sale was due to be held under the terms of said notice between the legal hours of sale, said foreclosure was duly and properly conducted and Patrick O. Gray as Attorney-in-Fact for the said Green Tree Servicing LLC did offer for sale and sell at public outcry, at the Courthouse in Shelby County, Alabama, the property hereinafter described; and

WHEREAS, Patrick O. Gray was the Auctioneer who conducted said foreclosure sale for the said Green Tree Servicing LLC; and

WHEREAS, the said Green Tree Servicing LLC was the highest bidder in the amount of Thirty Seven Thousand Four Hundred Seventy Nine and 87/100 Dollars (\$37,479.87), which sum of
