FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 10th day of November, 2005, Melissa T Cundiff and Gregory K Cundiff, joint tenants with Rights of Survivorship, wife and husband, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. solely as nominee for HMSV-USB Lending, LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number: 20051116000599390, said mortgage having subsequently been transferred and assigned to Deutsche Bank National Trust Company, as Trustee of the Residential Asset Securitization Trust 2006-A3CB, Mortgage Pass-Through Certificates, Series 2006-C under the Pooling and Servicing Agreement dated March 1, 2006, by instrument recorded in Instrument No. 20101008000335910, in the aforesaid Probate Office ("Transferee"); and
