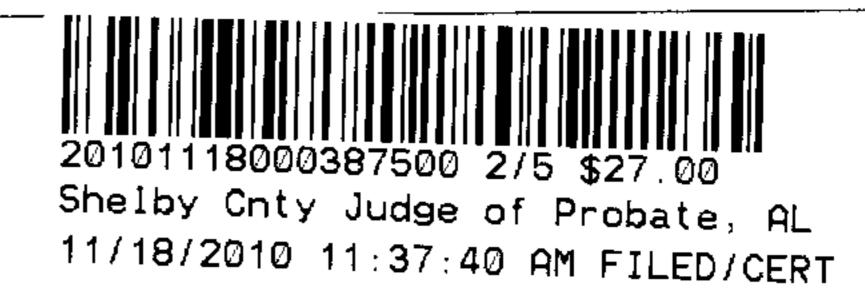

SUBORDINATION AGREEMENT

THIS SUBORDINATION AGREEMENT is made this Twenty-ninth day of October, 2010, by MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, Inc. WHEREAS, MARTIN INGELS executed and delivered to Subordinated Lienholder, a Deed of Trust/Mortgage (the "Existing and Continuing Security Instrument") in the sum of \$63240.00 dated 03/30/2007, and recorded in Book Volume N/A, Page_N/A, as Instrument No. 20070522000236730, in the records of SHELBY County, State of AL, as security for a loan (the "Existing and Continuing Loan"), which Existing and Continuing Security Instrument is a valid and existing lien on the real property

WHEREAS, MARTIN INGELS ("Borrower") executed and delivered to Bank of America, N.A.
