WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

STATE OF ALABAMA JEFFERSON COUNTY

KNOW ALL MEN BY THESE PRESENTS,

That in consideration of Ten and 00/100 (\$10.00) Dollars to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Robert L. Coker, Jr., and wife, Tami L. Coker (herein referred to as grantors) do grant, bargain, sell and convey unto Robert L. Coker, Jr. and Tami L. Coker (herein referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate situated in SHELBY County, Alabama to-wit:

The purpose of this conveyance is only to change the distribution of the grantors property into two new parcels. No new property is acquired through this conveyance and the property conveyed is the exact property as was vested in grantors prior to this conveyance.
