ARTICLES OF INCORPORATION
OF
TWO FEATHERS MINISTRIES

PURSUANT TO THE PROVISIONS OF THE ALABAMA NON-PROFIT CORPORATION ACT, THE UNDERSIGNED HEREBY ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION.

Article I The name of said corporation shall be Two Feathers Ministries.

Article II The corporation shall have perpetual existence.

Article III The corporation shall be formed for the purposes of providing, in the name of Jesus Christ, physical and spiritual aid and assistance to individuals suffering deprivation, hardship or poverty, especially to those who are members of or descended from First Nations (Native American) tribes of North American, within the purview of Section 501 (c)(3) of the Internal Revenue Code and the regulations thereunder, and as authorized by the Alabama Non-Profit Corporation Act (Title 10, Chapter 3A of the Code of Alabama of 1975, as amended) in furtherance of the gospel and kingdom of the Lord Jesus Christ and in accordance with the commandments and principles contained within the Bible.

Article IV The corporation shall have no members or shareholders.


