

MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore, on to-wit, June 21, 2007, Kimberly J Vandegriff, an unmarried person, Mortgagor, did execute a certain mortgage to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for First American Bank, which said mortgage is recorded in Instrument No. 20070627000302940, in the Office of the Judge of Probate of Shelby County, Alabama; and

WHEREAS, the said Mortgage Electronic Registration Systems, Inc., acting solely as nominee for First American Bank, transferred and assigned said mortgage and the debt thereby secured to Alabama Housing Finance Authority, as transferee, said transfer is recorded in Instrument No. 20100828000318580, aforesaid records, and Alabama Housing Finance Authority, as transferee is now the holder and owner of said mortgage and debt; and

WHEREAS, default was made in the payment of indebtedness secured by said mortgage, and the said Alabama Housing Finance Authority as transferee, did declare all of the indebtedness secured by said mortgage due and payable and did give due and proper notice of foreclosure of said mortgage, in accordance with the terms thereof, by First Class Mail and by publication in the Shelby County Reporter, a newspaper of general interest and circulation in Shelby County, Alabama, in its issues of 10/13, 10/20 and 10/27/2010; and

WHEREAS, on November 4, 2010, the day on which the foreclosure sale was due to be held under the terms of said notice at o'clock arn/pm, between the legal hours of sale, said foreclosure was duly and properly conducted and Alabama Housing Finance Authority did offer for sale and sell a public outcry, in front of the main entrance of the courthouse door of the Shelby County, Alabama Courthouse, in the City of Columbiana, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid for cash obtained for the property described in the aforementioned mortgage was the bid of Alabama Housing Finance Authority in the amount of ONE HUNDRED TWENTY THOUSAND SIX HUNDRED TWENTY-FIVE AND 56/100 DOLLARS (\$120,625.56) which sum the said Alabama Housing Finance Authority offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to the said Alabama Housing Finance Authority; and

WHEREAS, said mortgage expressly authorized the mortgagee to bid at the sale and purchase said property, if the highest bidder thereto, and authorized the Mortgagee, Auctioneer, or any person conducting said sale for the Mortgagee to execute to the purchaser at said sale a deed to the property so purchased;

NOW, THEREFORE, in consideration of the premises and the credit of ONE HUNDRED TWENTY THOUSAND SIX HUNDRED TWENTY-FIVE AND 56/100 DOLLARS (\$120,625.56), cash, on the indebtedness secured by said mortgage, the said Kimberly J Vandegriff, an unmarried person, acting by and through the said Alabama Housing Finance Authority as transferee, by Fran Clark as auctioneer and the person conducting said sale for the Mortgagee or Transferee of Mortgagee, does hereby grant, bargain,

sell and convey unto Alabama Housing Finance Authority, and its successors and assigns, as transferee, the following described real property, situated in Shelby County, Alabama, to-wit:
