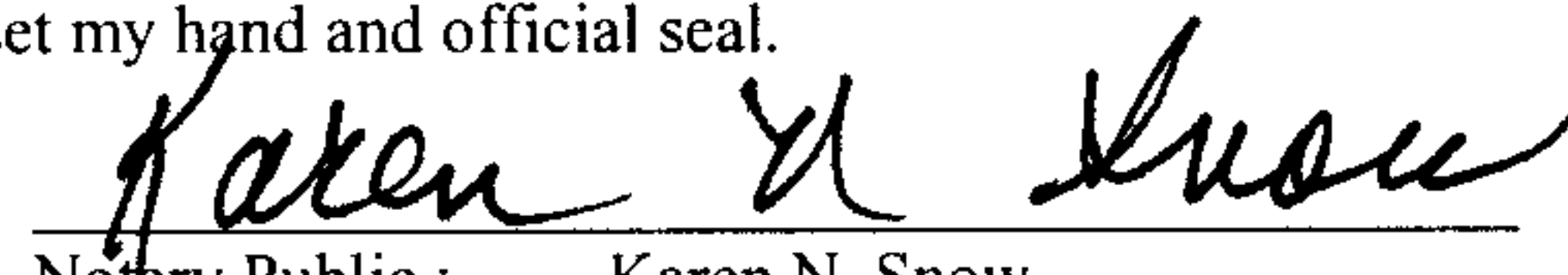

A parcel of land lying in the SE corner of the SW 1/4, Section 12, Township 20 South, Range 2 West, more particularly described as follows: starting at the NE corner of said SE 1/4 of the SW 1/4 of Section 12 and run southerly along the east boundary of said 1/4-1/4 a distance of 444.47 feet to a railroad spike driven in the west side of a paved county road, said point being the point of beginning; thence continue southerly along said east boundary line for a distance of 210.0 feet to a railroad spike on the east side of said paved county road.
