FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 6th day of June, 2006, Melissa Glover, an unmarried woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. solely as nominee for MortgageAmerica, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number: 20060626000306060, said mortgage having subsequently been transferred and assigned to Fannie Mae ("Federal National Mortgage Association"), by instrument recorded in Instrument no. 20101102000367390, in the aforesaid Probate Office ("Transferee"); and

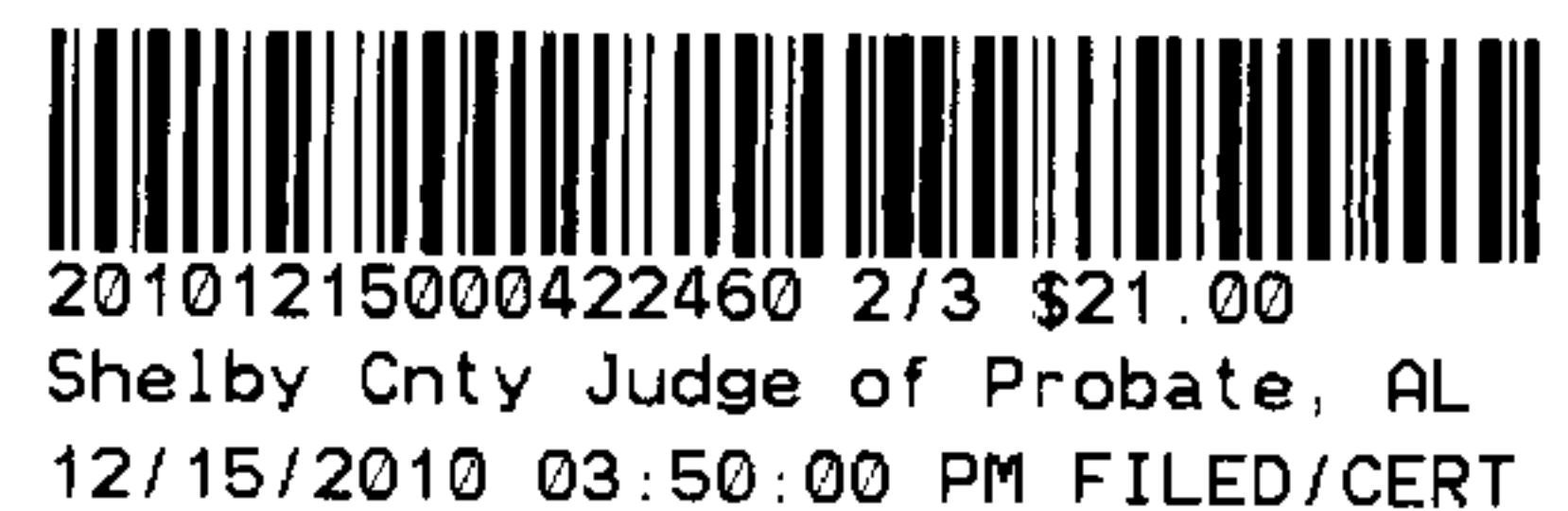
