FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 25th day of June, 2007, Ronald L. Moore, Individual, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for CitiMortgage, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070709000321640, said mortgage having subsequently been transferred and assigned to CitiMortgage, Inc. , by instrument recorded in Instrument 20101117000385530, in the aforesaid Probate Office ("Transferee"); and

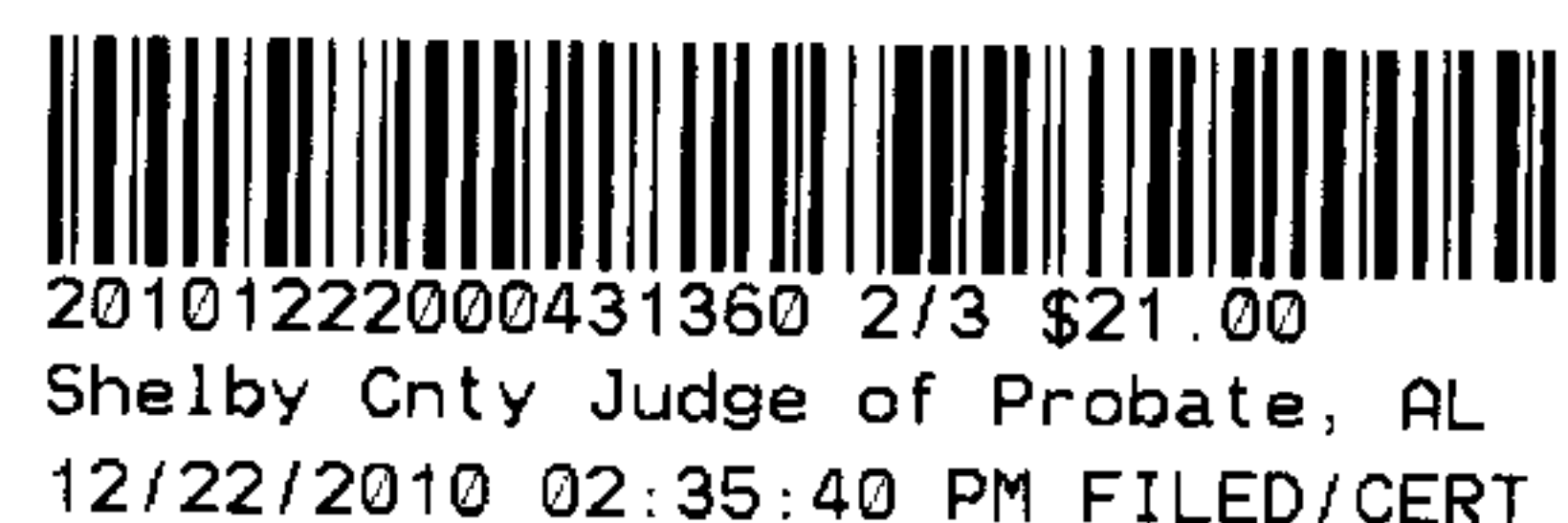


