

FIRST AMENDED ARTICLES OF INCORPORATION
OF
HOUSE LEGAL SERVICES, P.C.

**TO THE HONORABLE JUDGE OF PROBATE,
SHELBY COUNTY, ALABAMA:**

Pursuant to the Revised Alabama Professional Corporation Act, the undersigned, **Linda J. House**, acting as the sole incorporator of the professional corporation, hereby adopts the following amendments to the Articles of Incorporation of the professional corporation:

The name of the professional corporation is **HOUSE LEGAL SERVICES, P.C.**

The professional corporation's Articles of Incorporation were filed with the Shelby County Probate Judge in the Probate office on August 4, 2009, recorded as Instrument Number 20090804000299070.

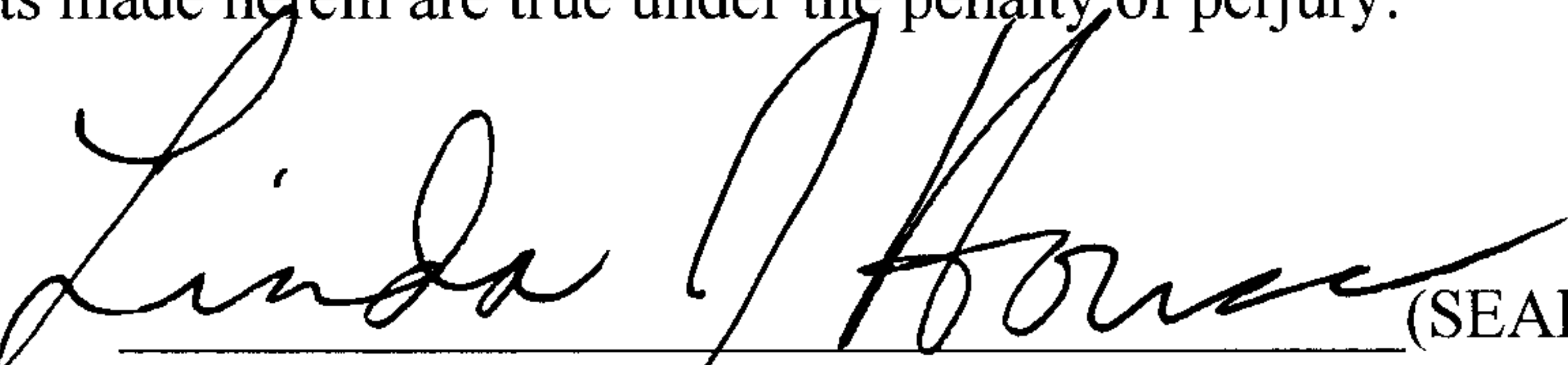
