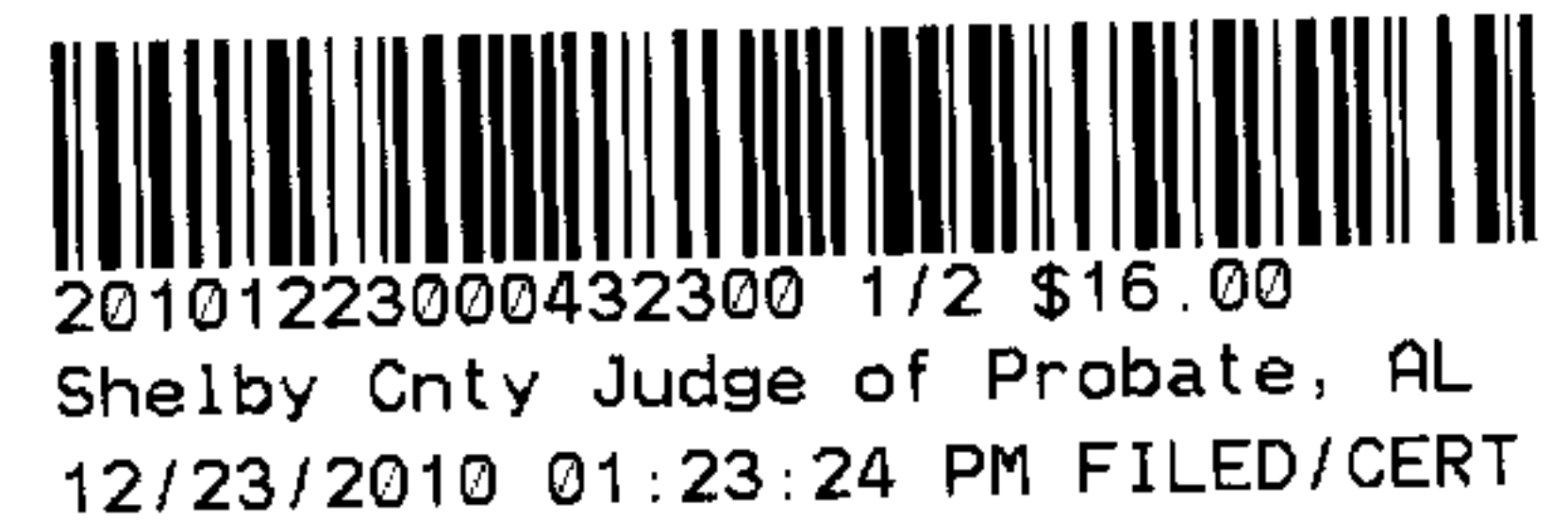

WARRANTY DEED



KNOW ALL MEN BY THESE PRESENTS:

That is consideration of One Hundred Forty-Five Thousand Seven Hundred and 00/100 Dollars (\$145,700.00) in hand paid to the undersigned, ADAMS HOMES, LLC (hereinafter referred to as "Grantor") by NATHAN B. SMITH and ELIZABETH SMITH (hereinafter referred to as Grantees"), the receipt and sufficiency of which are hereby acknowledged, Grantor does, by these presents, grant, bargain, sell, and convey unto Grantees, as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 64, according to the map of Stoney Moeadows Phase 1, as recorded in Map Book 36, page 107, together with the Affidavit of Michael R. 
