The dissolution of the Company was authorized as of December 15, 2010.

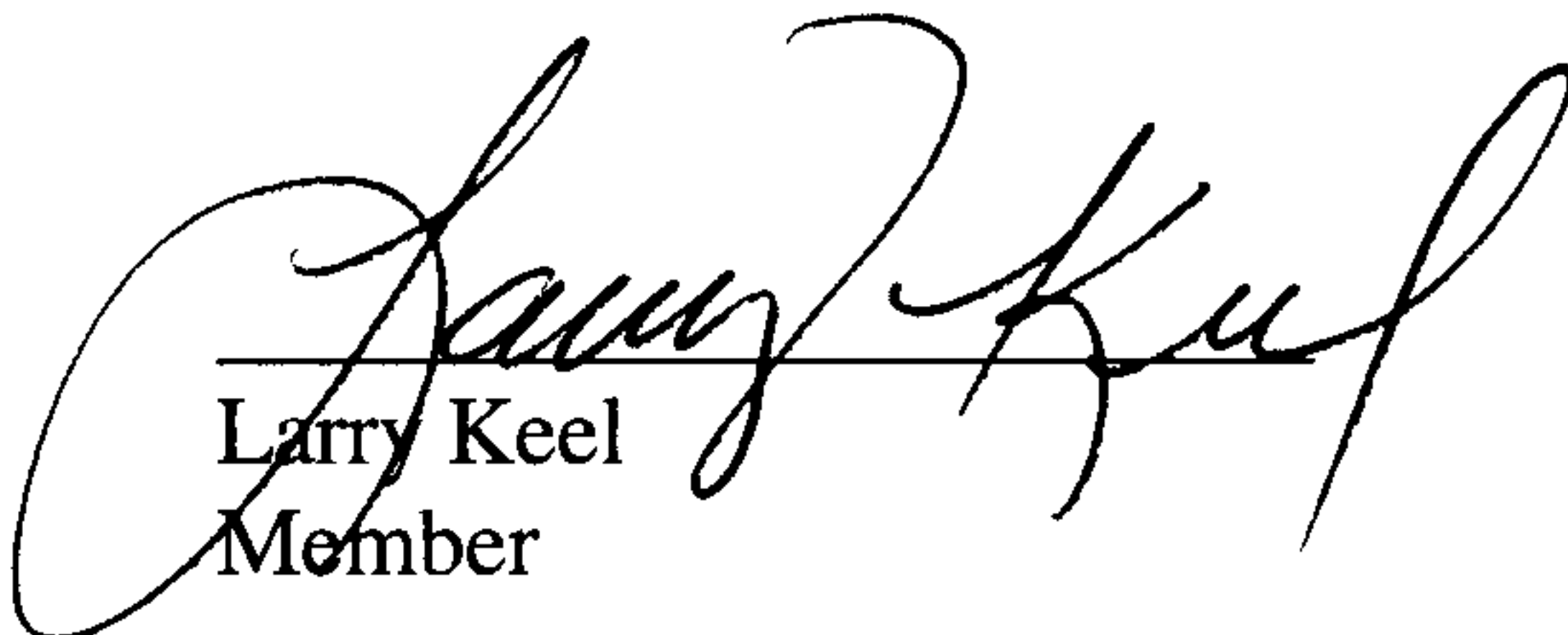
ARTICLE III

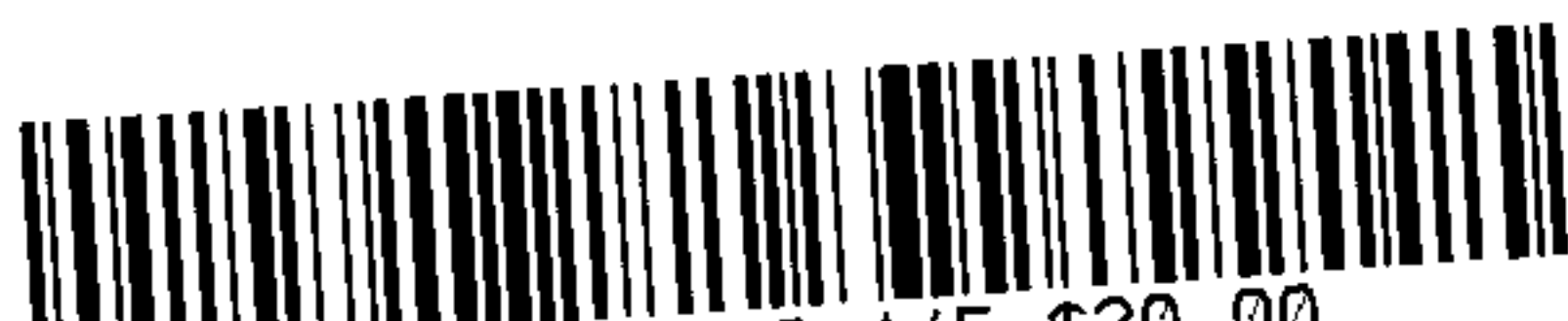
ARTICLE IV

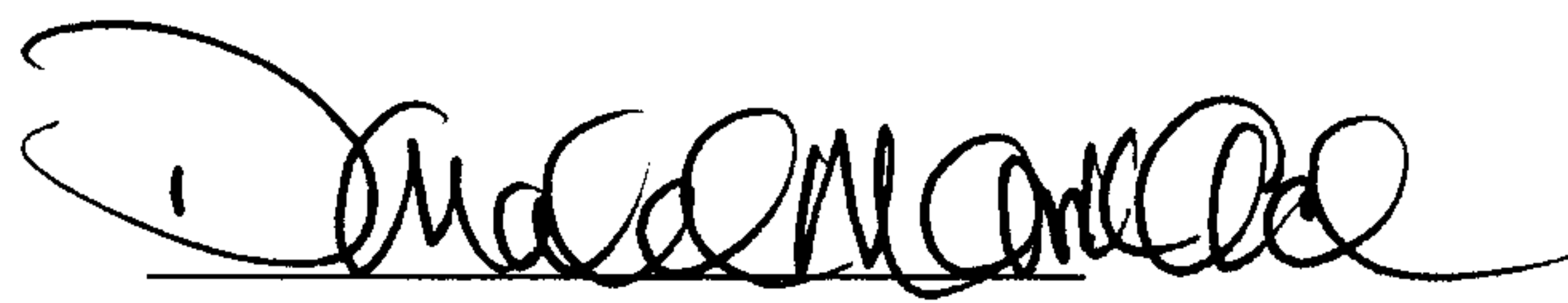
The dissolution of the Company is to be effective upon the filing of these Articles of Dissolution with the Office of the Judge of Probate of Shelby County, Alabama.

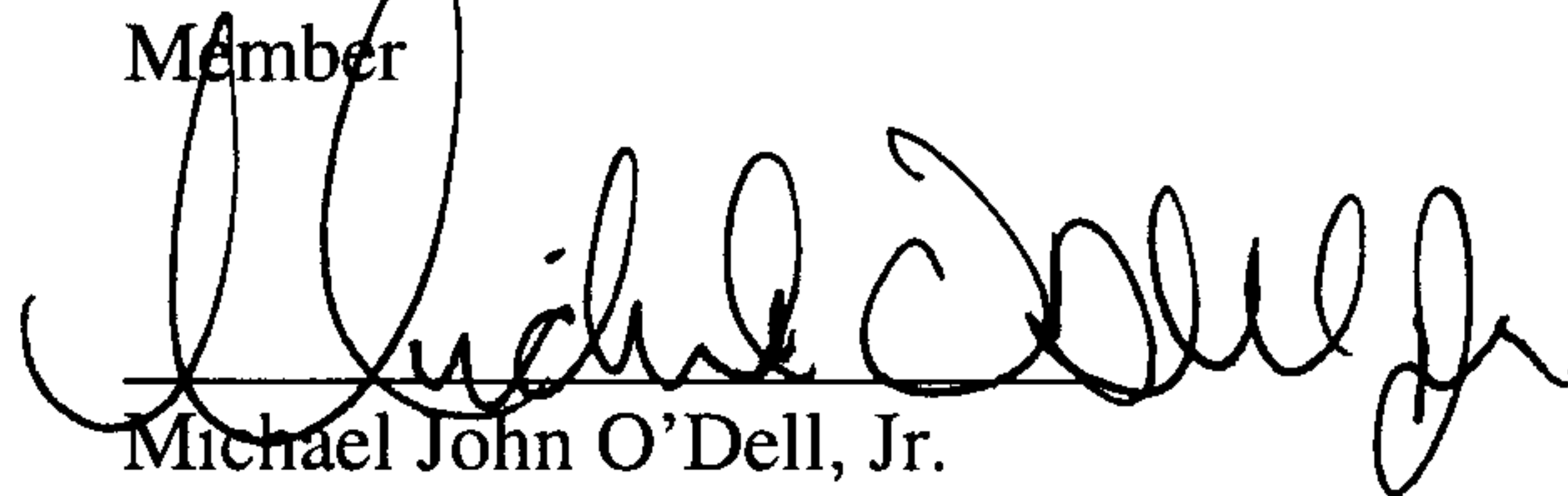

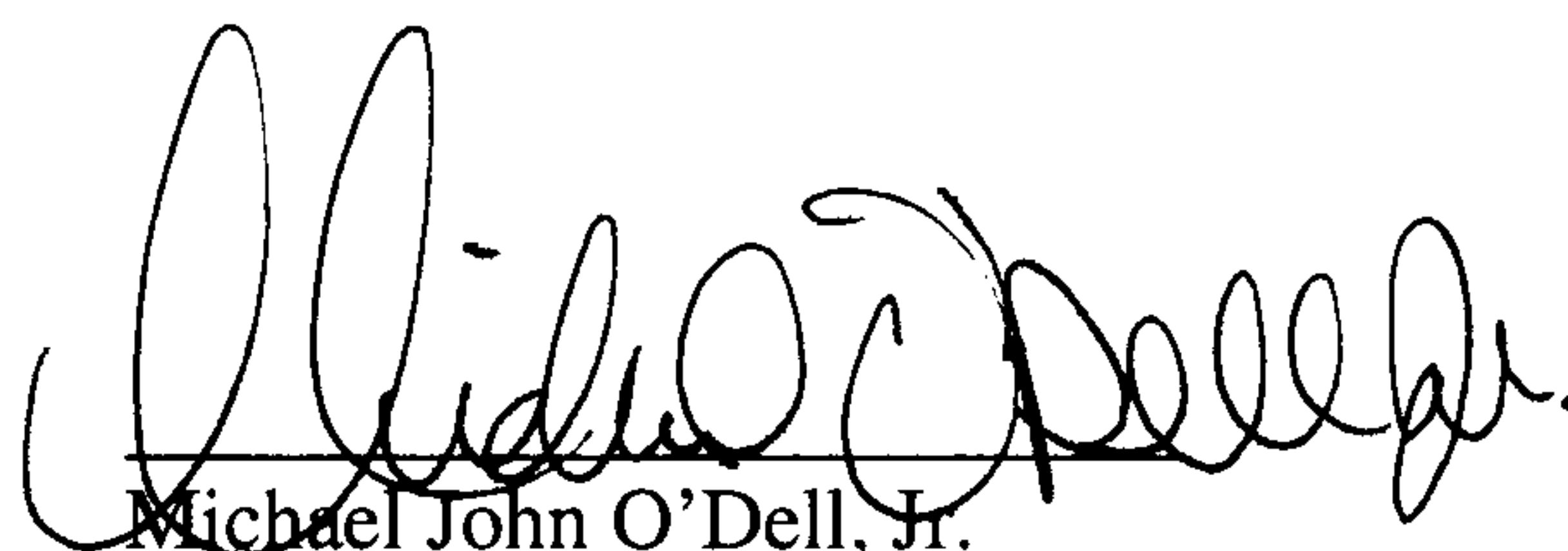
