
Article I: Pursuant to the provisions of §10-12-42 the name the limited liability company is:

Article II: The *Articles of Organization* of SunSpot, LLC, a limited liability company, were filed in the Probate Court of **Shelby County**, Alabama on June 4, 2001 and recorded at **Inst # 2001-22646**.

Article III The members unanimously agree that it is no longer feasible for the limited liability company to continue in existence. Pursuant to §10-12-37(2) the dissolution of SunSpot, LLC is authorized by the following written consent of all of the members of SunSpot, LLC, *to-wit:*

Pursuant to the provisions of Chapter 12 of the Alabama Limited Liability Company Act, the undersigned, being all of the members of SunSpot, LLC, by execution hereof do hereby (i) consent to and adopt the following resolution as of the date hereof, which resolution shall have the same force and effect as if adopted by unanimous affirmative vote at a meeting of the members of the limited liability company duly called and held; (ii) waive all requirements of notice; and (iii) direct that this written consent be filed with the minutes of the proceedings of the limited liability company:

Article IV: Pursuant to the provisions of §10-12-42(4) these *Articles of Dissolution* shall be effective immediately.


