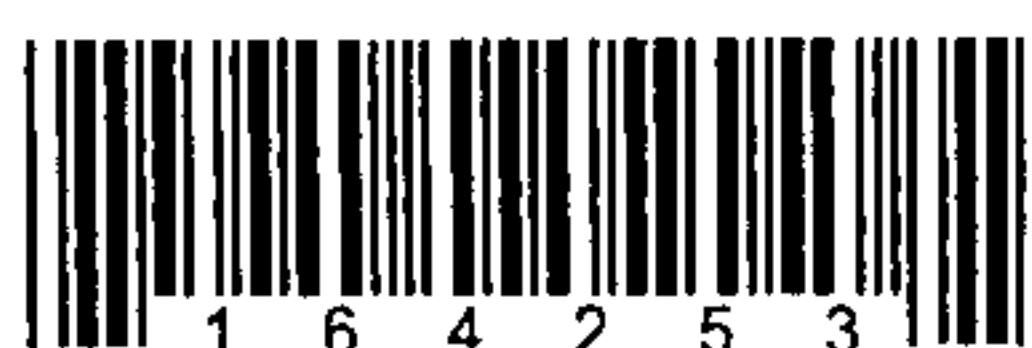
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 21st day of March, 2008, John A. Veal, Jr. and wife, Susan S. Veal, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Walton Mortgage Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20080328000127240, said mortgage having subsequently been transferred and assigned to Flagstar Bank, F.S.B., by instrument recorded in Instrument Number 20101103000367920, in the aforesaid Probate Office ("Transferee"); and

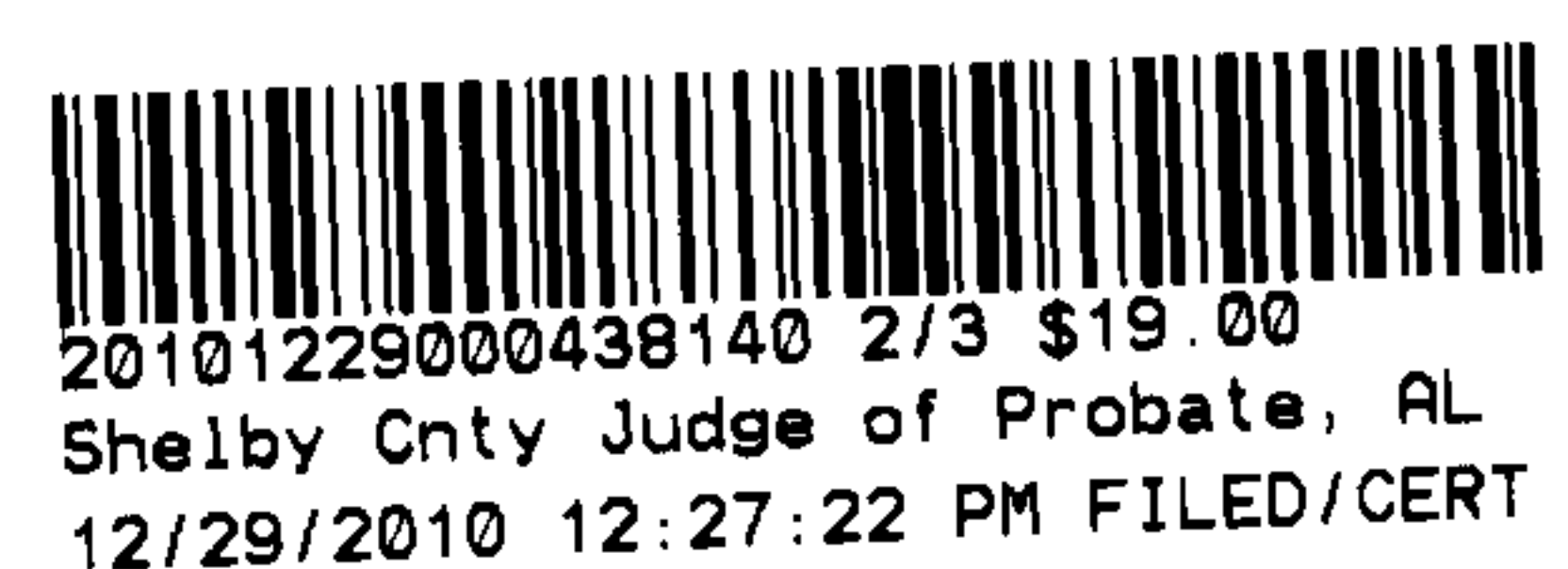
