

## Attached Legal Description

## PARCEL 1

THENCE N 89°36'02" W, ALONG SAID FENCE, A DISTANCE OF 1302.32 FEET TO AN IRON, FOUND STAMPED "F. WHEELER", ON THE EAST RIGHT-OF-WAY OF COUNTY HIGHWAY 49;

THENCE N 00°58'02" E, ALONG SAID RIGHT-OF-WAY, A DISTANCE OF 26.84 FEET TO THE SOUTH LINE IF THE NORTH HALF OF THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION 6;
