FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 31st day of July, 2007, Stephen Harrison and Lisa Harrison, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for Superior Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070803000363650, said mortgage having subsequently been transferred and assigned to CitiMortgage, Inc., by instrument recorded in Instrument 20101210000414120, in the aforesaid Probate Office ("Transferee"); and

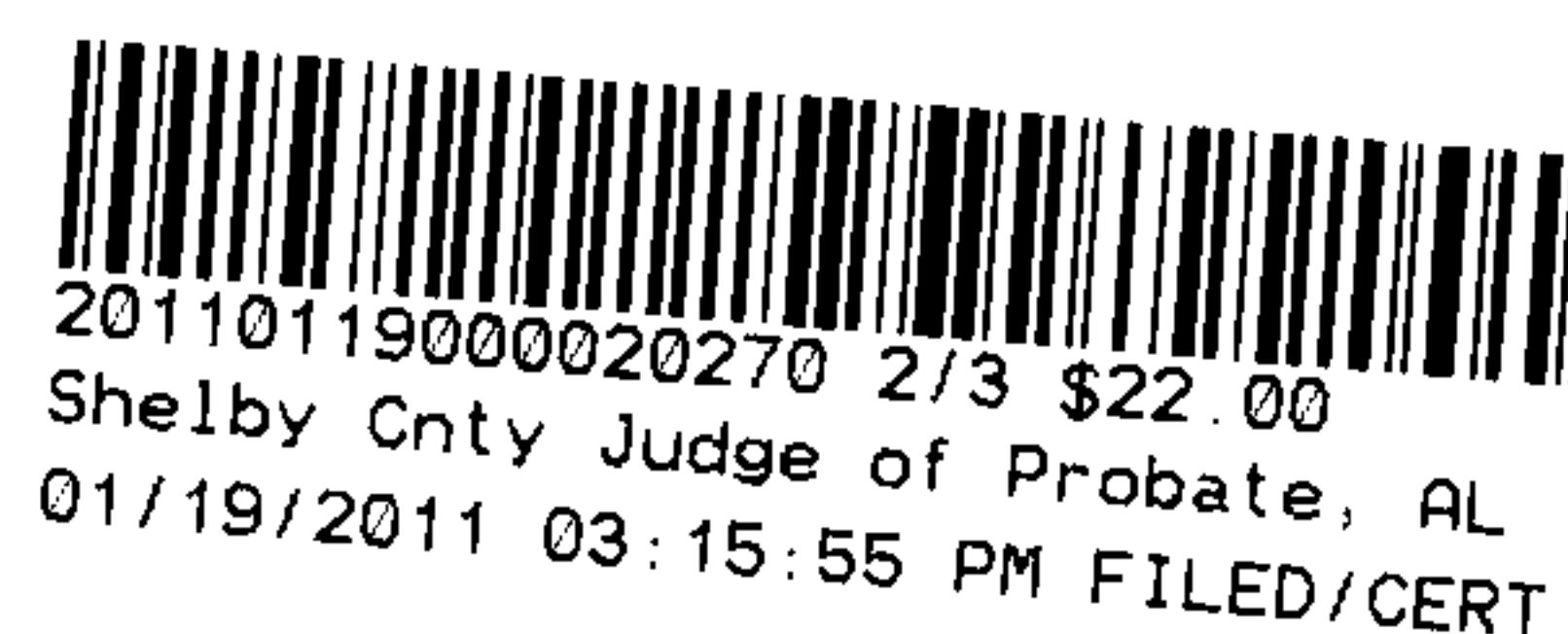


