

**ARTICLES OF ORGANIZATION OF *BINION HOMES*, LIMITED LIABILITY  
COMPANY/L.L.C./LLC**

Pursuant to the Provisions of the Section 10-12-1, et seq. Of the Code of Alabama (1975), the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

**Article I**

*Name*

The name of the limited liability company is, ***BINION HOMES***, Limited Liability Company/L.L.C./LLC

**Article II**

*Duration*

The Company shall have a perpetual duration from the date of organization, unless it is dissolved and its affairs are wound up prior to the date in accordance with the Alabama Limited Liability Company Act.

**Article III**

*Purposes*

The purposes for which the company is formed are:

- (a) To provide property management services which includes but is not limited to: investing, purchasing, improving, renting and selling real estate.
- (b) To act as agent, representative, or receiver of any person, firm, corporation, or governmental entity or instrumentality in respect to any lawful undertaking or transaction.
- (c) To purchase, take, receive, lease or otherwise acquire, own hold, improve, use and otherwise deal with in or with, real personal property, or any interest therein, wherever situated, and to sell, convey, mortgage, pledge, lease exchange, transfer and otherwise dispose of real personal property, or any interest therein;
- (d) To engage in any other lawful act or activity for which limited liabilities companies may be organized pursuant to the Act.


**ARTICLE VI**


