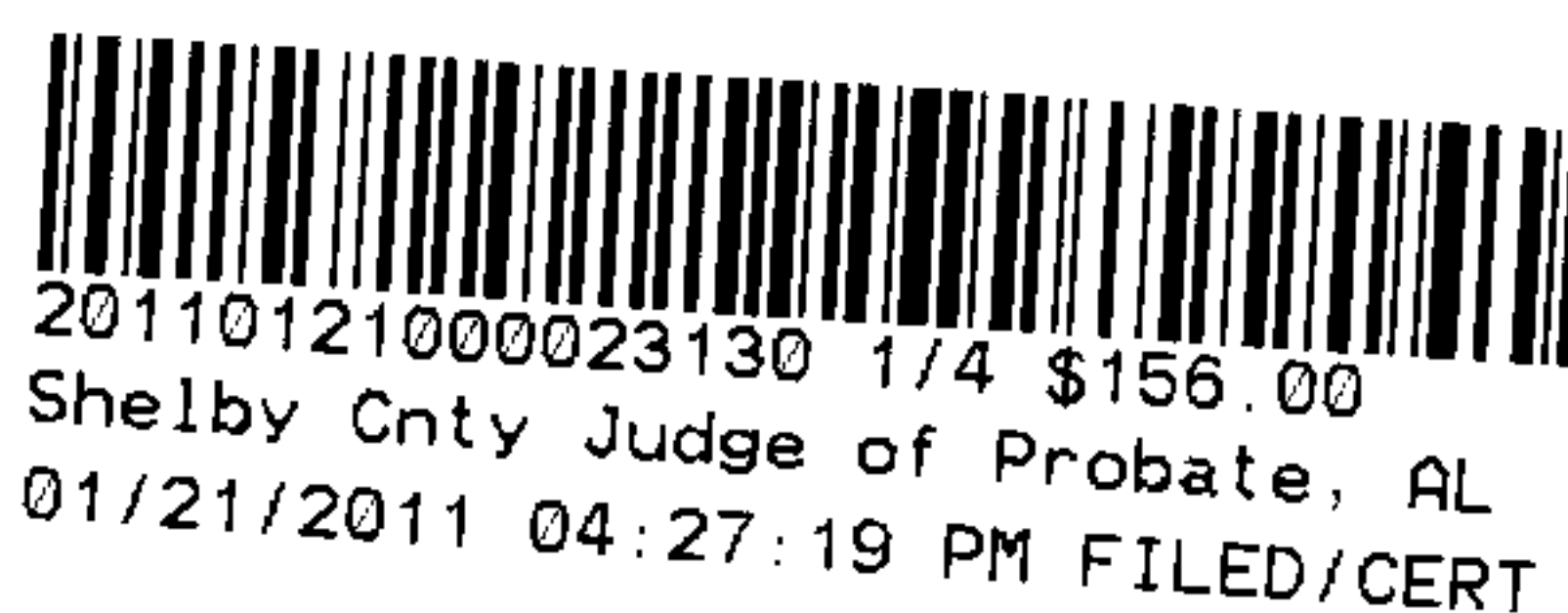
ARTICLE THREE

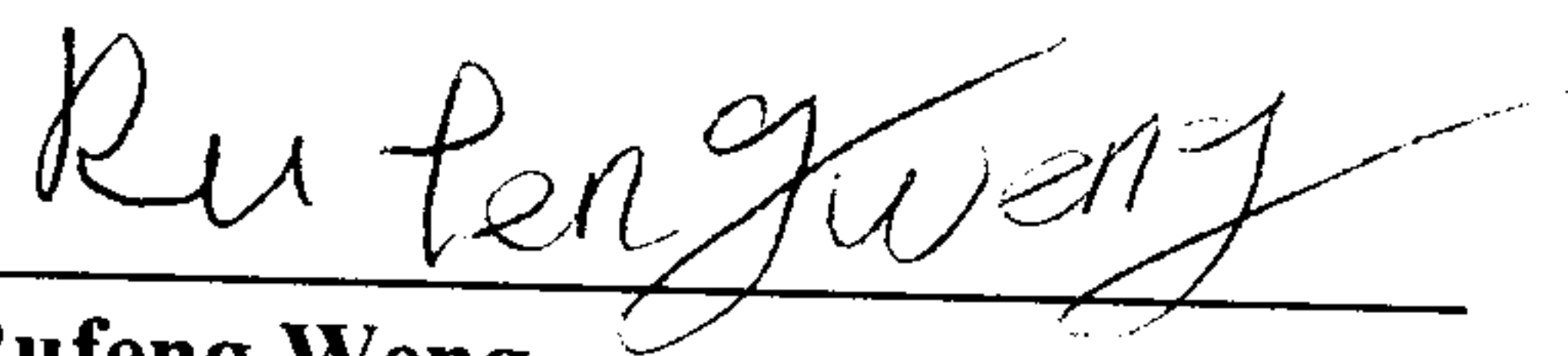
ARTICLE NINE


The limited liability company shall have one manager who shall serve until the first annual meeting or until their successor(s) are elected and qualified. The initial two managers shall be:

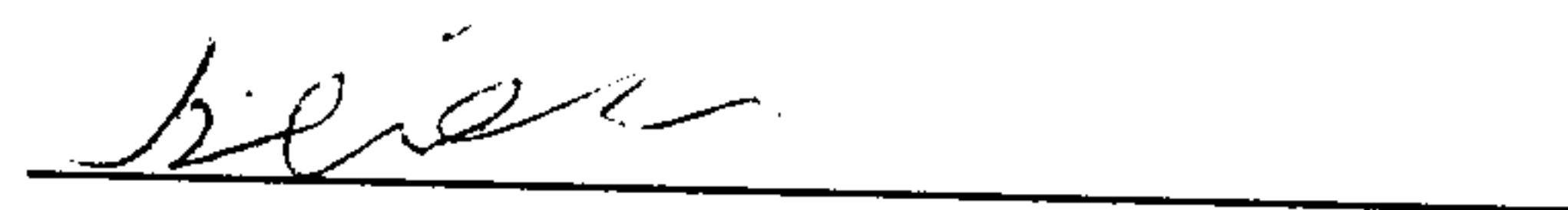

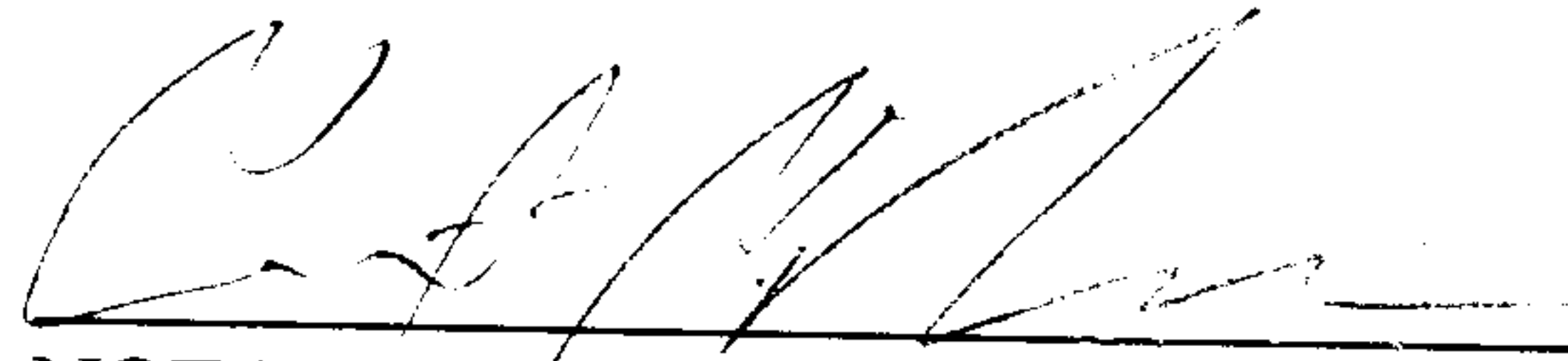
