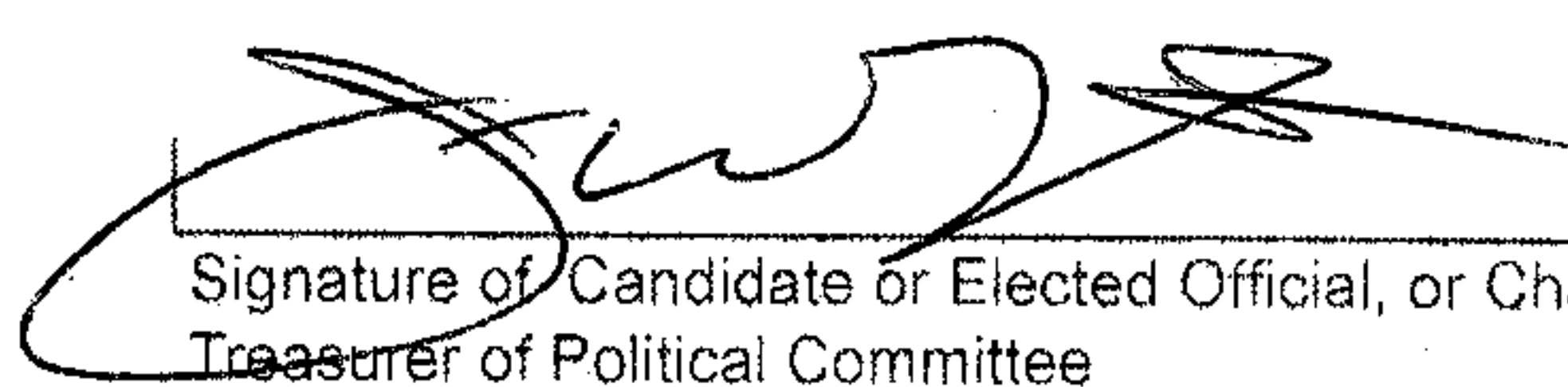

- ▶ \$5,000 - candidates for district or circuit offices
- ▶ \$1,000 - candidates for local offices
