LOAN MODIFICATION AGREEMENT

+ DATED December 13, 2010 but effective AS OF This Loan Modification Agreement ("Agreement"), made this 1st day of January MICKEY L MCDANIEL and PAMELA R MCDANIEL, Husband and wife between and RBS Citizens, N.A. f/k/a Citizens Bank, N.A. s/b/m to CCO ("Borrower") f/k/a/ Charter One Mortgage Corp. ("Lender") Mortgage corp. supplements (1) the Mortgage Deed of November 6, 2003, The original Principal sum of TWO HUNDRED EIGHTY FIVE THOUSAND and 00/100 (\$285,000.00) and recorded in Instrument #20031114000754350 of County of Shelby County Judge of Probate official land records of County of Shelby County, Alabama and (2) the Balloon Note (the "Note") bearing the same date as, and secured by, the Security Instrument, which covers the real and personal property described in the Security Instrument #20031114000754350 defined herein as the "Property", and located at 5407 SPRING CREEK ROAD, MONTEVALLO, ALABAMA 35115.

In consideration of the mutual promises and agreements exchanged, the parties hereto agree as follows (notwithstanding anything to the contrary contained in the Note or Security Instrument):

- 1. Immediately prior to the execution of this Agreement, the lien of the Security Instrument is valid and subsists against the Property, and secures repayment of the amount of U.S. \$251,125.97 (the "Unpaid Principal Balance"), consisting of the unpaid amount loaned to the Borrower by the Lender, including advances, if any, to which Borrower has no defenses, off-sets or counterclaims.
- The Borrower promises to pay the Unpaid Principal Balance, plus interest, to the order of the Lender at the yearly rate of 4.375% from and after <u>December 1, 2010</u>. The Borrower promises to make monthly payments of principal and interest of US \$1,444.69 beginning <u>January 1, 2011</u>, and continuing thereafter on the same day of each succeeding month until principal and interest are paid in full.
