

**ARTICLES OF ORGANIZATION

**ARTICLE I

**CESSATION OF MEMBERSHIP**

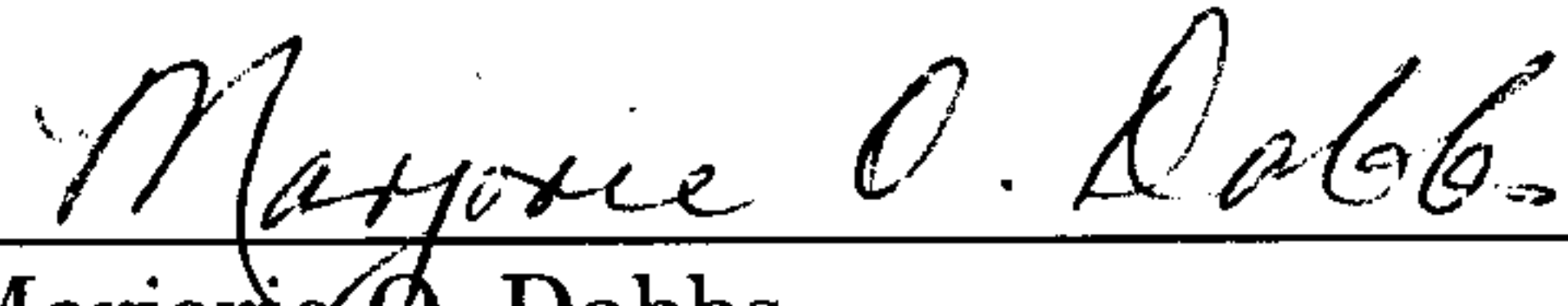
