

ARTICLES OF ORGANIZATION OF

J & A DENT REMOVAL LLC A LIMITED LIABILITY COMPANY ORGANIZED UNDER THE LAWS OF ALABAMA

- 5. The names and address of the initial member of the Company is:

- 6. The initial member of the Company may admit additional members at such times and upon such terms and conditions as may be agreed by the Company and the additional members.
- 7. The legal existence and business of the Company may be continued by the written consent of all the remaining members within thirty (30) days after an event of disassociation of a member.
 - 8. The Company shall be managed by one or more managers. The names and mailing addresses of the initial managers, who shall serve as manager until the first annual meeting of members of the Company or until their successor[s] is [are] duly elected, is [are]:
