

ARTICLES OF INCORPORATION OF

The undersigned, Jennifer C. Moore, acting as incorporator of a corporation under the provisions of the Code of Alabama, Section 10A-2-2.01, et al., adopts the following Articles of Incorporation for the Corporation:

- 1. The name of the Corporation is **Compliance Engineered Film, Inc.**, and the Corporation is authorized to operate under that name or use any other trade name.
- 2. The Corporation is formed for the purpose of manufacturing, producing acquiring and selling products and materials for coating underground pipe and any other related activities and to transact any and all lawful business for which corporations may be incorporated under the laws of the State of Alabama.


