FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 26th day of October, 2005, James Quick aka James D. Quick, a married person and Kimberlie Quick aka Kimberlie C. Quick, a married person, executed that certain mortgage on real property hereinafter described to American Express Bank, FSB, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number: 20051109000584960, said mortgage having subsequently been transferred and assigned to PHH Mortgage Corporation, by instrument recorded in 20110106000007360, in the aforesaid Probate Office ("Transferee"); and
