FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 8th day of February, 2002, Dennis L. Taylor, Jr. and Amber N. Taylor, husband and wife , executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. solely as nominee for MortgageSouth, LLC, an Alabama Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument number: 2002-10987; modified by Modification Agreement in Instrument No. 20031006000670700, said mortgage having subsequently been transferred and assigned to Aurora Loan Services, LLC, by instrument recorded in Instrument No. 20101025000356450, in the aforesaid Probate Office ("Transferee"); and




