Pursuant to the provisions of the Alabama Non-Profit Corporation Act, the undersigned hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME OF THE CORPORATION

The name of this corporation is Cristo Rey en Fuego Nuevo, Inc.

ARTICLE II

DURATION

The duration of the corporation is perpetual.

ARTICLE III

PURPOSES

The corporation has been organized for the following purposes:

(1) This nonprofit corporation is organized exclusively for one or more of the purposes as specified in §501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under §501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

(2) In addition to the powers and purposes otherwise granted by law to nonprofit corporations the Corporation is organized:

To promote and support the Hispanic peoples in North Central Alabama whether through cultural or religious events, through providing recreational and meeting space, the presentation of educational opportunities and through the creation of a community gathering place.

The foregoing clauses shall be construed as highlighting the some purposes for which the nonprofit corporation is organized, in addition to those powers specifically conferred upon the nonprofit corporation by law, and it is hereby expressly provided that the foregoing specific enumeration of powers shall not be held to limit or restrict in any manner the powers of the nonprofit corporation otherwise granted by law.

Notwithstanding any other provision of these Articles of Incorporation, this nonprofit corporation shall not engage in any activities that are not permitted (1) by a nonprofit corporation exempt from federal corporate income tax under §501(c)(3) of the Internal Revenue Code or (2) by a nonprofit corporation whose contributions are deductible under §170(c)(2) of the Internal Revenue Code.

ARTICLE IV

MEMBERS

The Corporation shall have no members.

ARTICLE V

REGISTERED OFFICE/ AGENT

The location and mailing address of the initial registered office shall be 1009 Stonecreek Drive, Helena, Alabama, 35080 and its registered agent at such address shall be Jorge Armando Padilla.

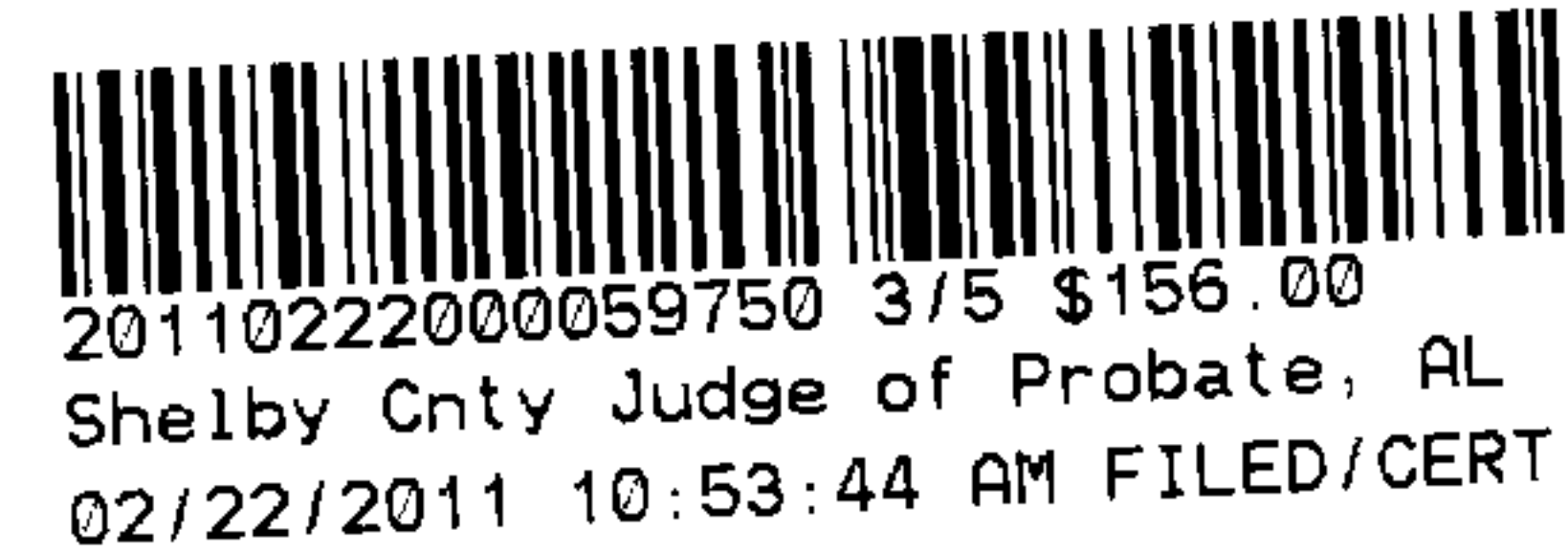

ARTICLE VIII
RIGHT TO AMEND PROVISIONS IN ARTICLES

The corporation reserves the right from time to time to amend, alter or repeal each and every provision contained in these Articles of Incorporation or to add one or more additional provisions, in the manner now or hereafter prescribed or permitted by the Alabama Non-profit Corporation Act.

ARTICLE IX

BYLAWS

Provisions for the regulation of the internal affairs of the corporation are contained in its Bylaws. Any provision, not inconsistent with the law, for the regulation of the internal affairs of the corporation may be included in the Bylaws.

ARTICLE X

DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the Catholic Diocese of Birmingham, Alabama for Hispanic ministries. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

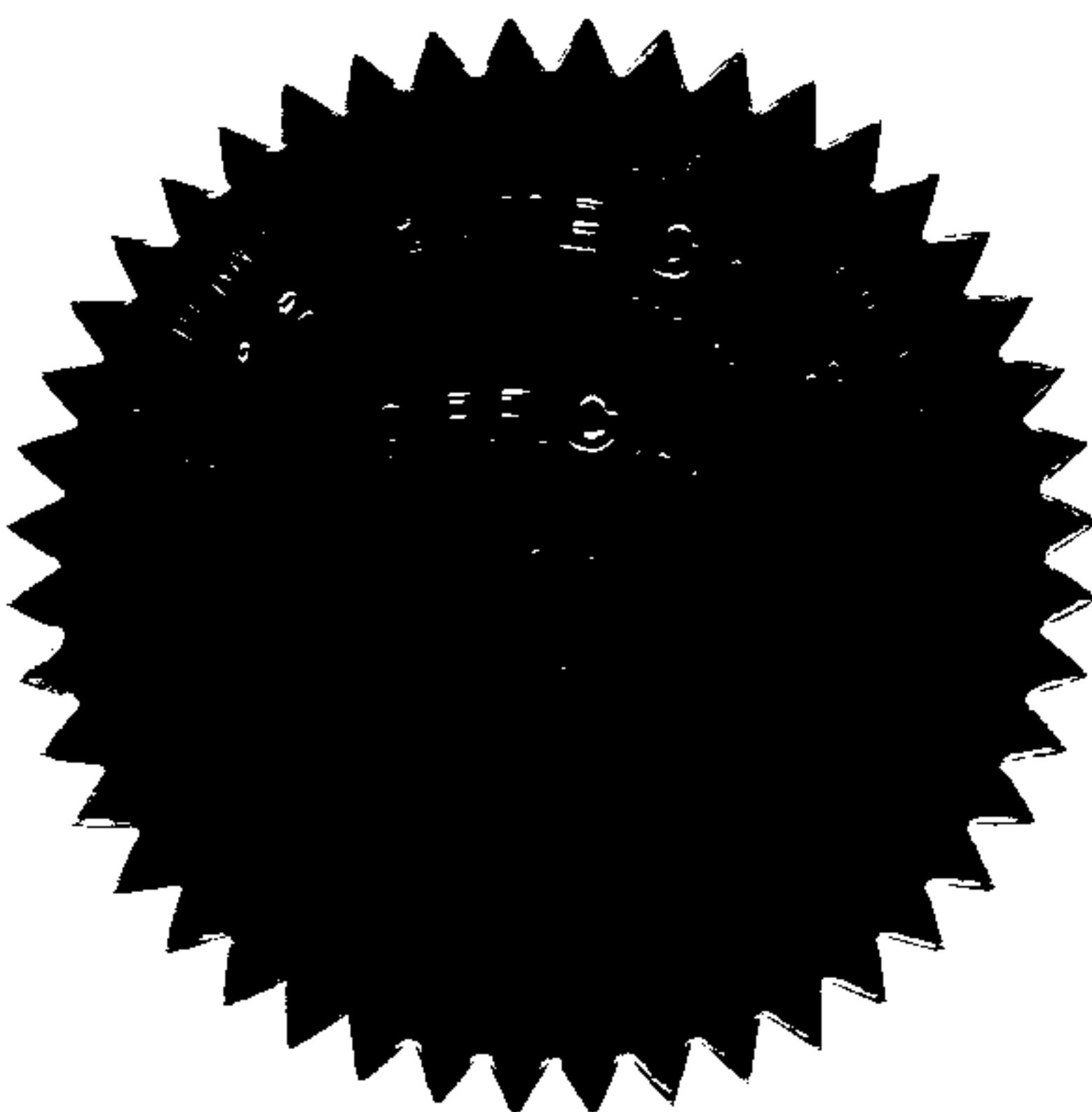
