FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 15th day of September, 2004, Michael C. Zofko, an unmarried man, executed that certain mortgage on real property hereinafter described to Mortgage Professionals, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20040927000530860, said mortgage having subsequently been transferred and assigned to Trustmark National Bank, by instrument recorded in Instrument Number 20040927000530870, in the aforesaid Probate Office ("Transferee"); and
