FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 24th day of December, 2008, Marc F. Selby and Stephanie D. Selby, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. solely as nominee for New South Federal Savings Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20090107000004080 and re-recorded in Instrument No. 20090218000057290, said mortgage having subsequently been transferred and assigned to EverBank, by instrument recorded in Instrument No. 20110120000020970, in the aforesaid Probate Office ("Transferee"); and
