FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 21st day of June, 2005, Jason Oliver Neal, an unmarried man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. solely as nominee for Hometown Mortgage Services, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20050628000318920, said mortgage having subsequently been transferred and assigned to EverBank, by instrument recorded in Instrument No. 20110120000020960, in the aforesaid Probate Office ("Transferee"); and

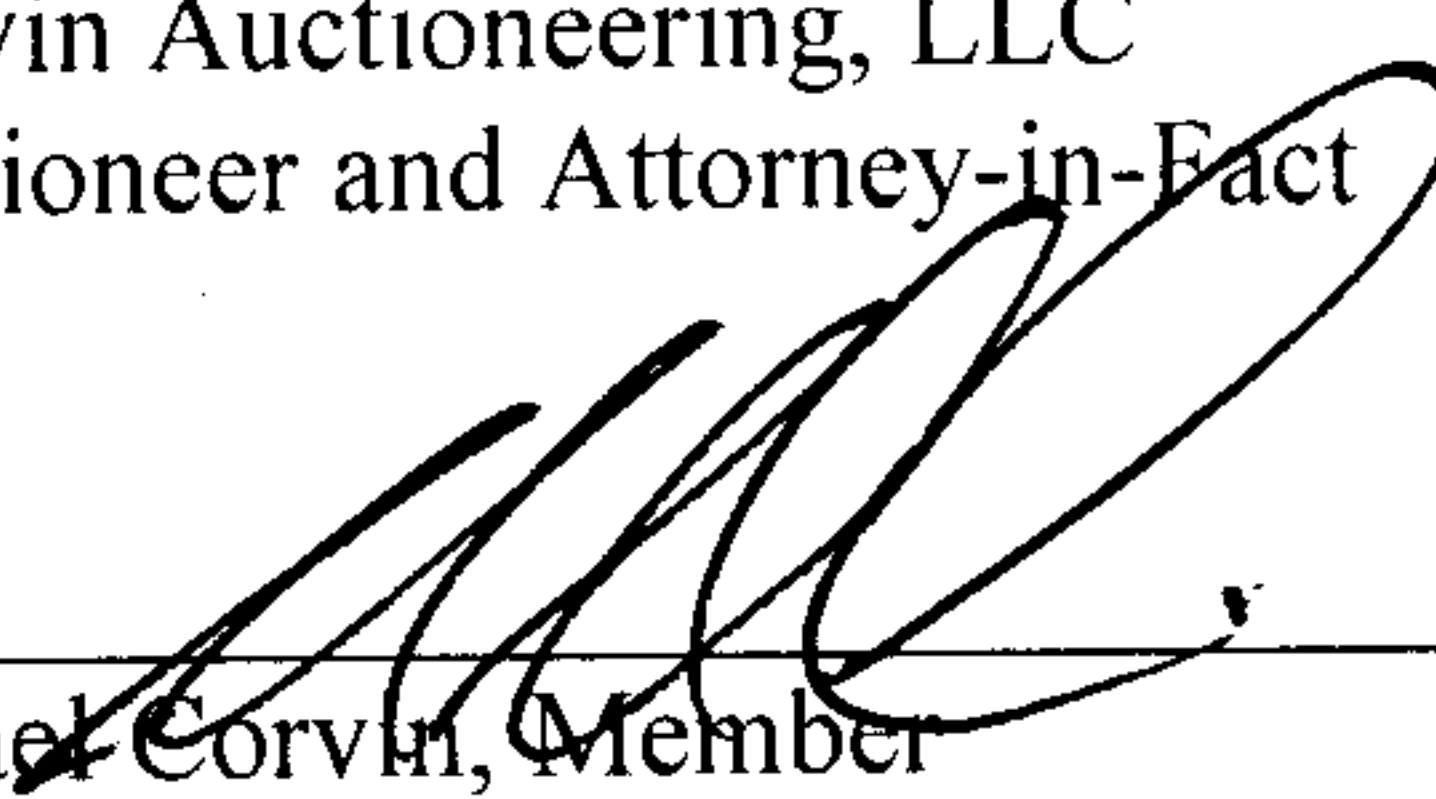

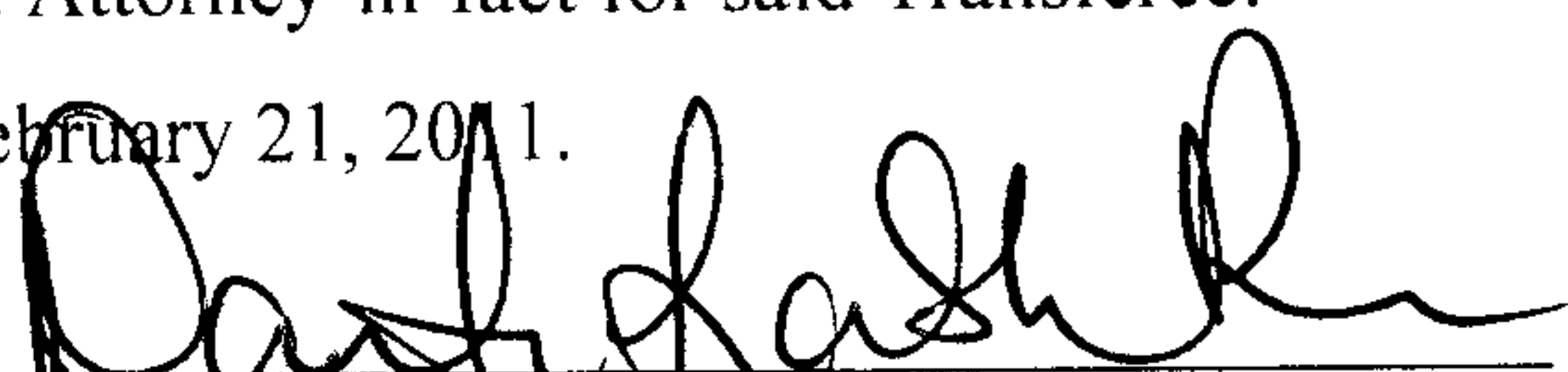
