WHEREAS, heretofore, on, to-wit: the 5th day of March, 2007, William B. Wade Jr., a married man and wife, Kendra M. 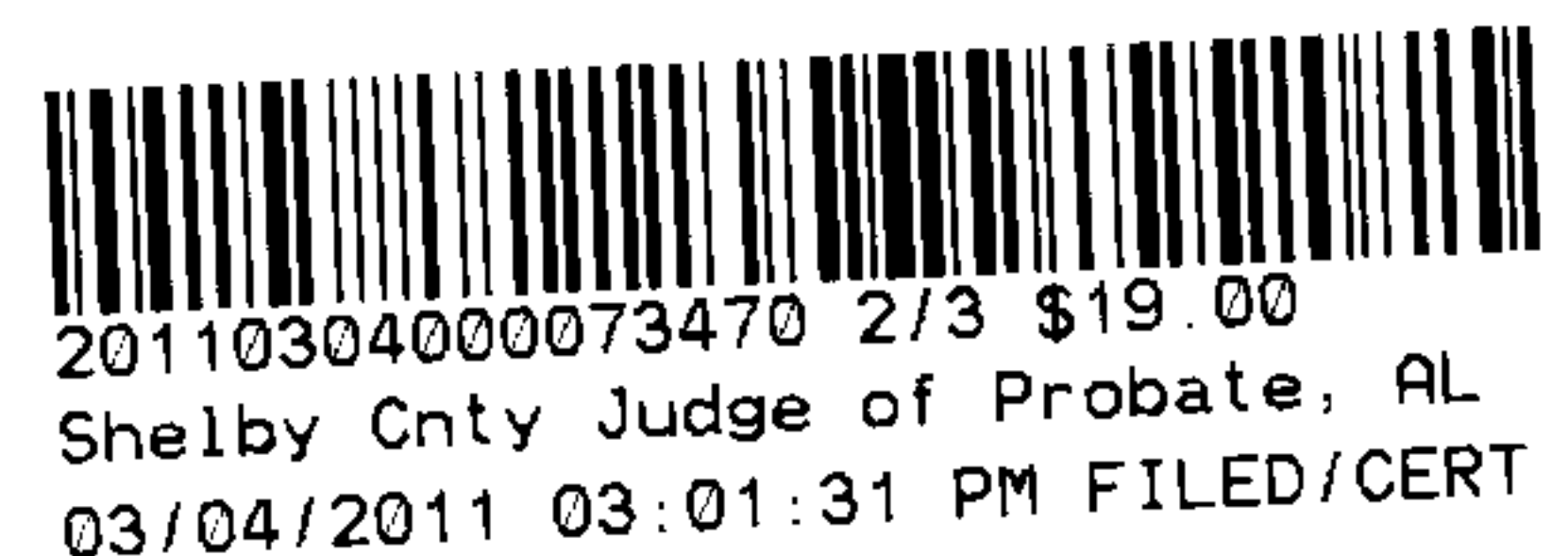


