

**DECLARATION OF RESULTS OF SPECIAL ELEVEN MILL DISTRICT  
SCHOOL TAX ELECTION IN SCHOOL TAX DISTRICT NO. 2  
IN SHELBY COUNTY, ALABAMA**

In accordance with the Resolution and Order of the Shelby County Commission of Shelby County, Alabama, made on November 8, 2010, a special election was held on February 8, 2011 in School Tax District No. 2 in Shelby County to determine whether a special district ad valorem tax shall continue to be levied and collected annually for public school purposes in School Tax District No. 2 in Shelby County at the uniform rate of one dollar and ten cents on each one hundred dollars worth of taxable property in said School Tax District No. 2 in said County (the boundaries of which School Tax District No. 2 are coterminous with the boundaries and include all of Shelby County, Alabama outside that part of Shelby County located within the corporate limits of the cities of Birmingham, Hoover, Leeds and Vestavia Hills) for a period of twenty-four (24) years beginning with the levy for the tax year October 1, 2017 to September 30, 2018 (the tax for which year will be due and payable October 1, 2018) and ending with the levy for the tax year October 1, 2040 to September 30, 2041 (the tax for which year will be due and payable October 1, 2041), said levy and collection, if authorized, not to increase the present eleven mill district school tax imposed pursuant to Amendment No. 3 and proceedings under Amendment No. 373 of the Constitution of Alabama of 1901, as amended, in said School Tax District No. 2 but to be in continuation thereof.

The Commission has found and determined that due notice of said election was given as required by law and by the Resolution and Order of the Commission, that the election was duly and legally held within School Tax District No. 2 in Shelby County as described above on February 8, 2011, that returns of said election have been made as provided by law, and does hereby report and declare, under oath, that the results of said election are as follows:

**11,298      FOR PROPOSED TAXATION**

**6,415      AGAINST PROPOSED TAXATION**


The Commission has ordered, adjudged and decreed that a majority of the qualified electors of School Tax District No. 2 in Shelby County voting at said special election voted in favor of the levy and collection of said tax, that said tax shall be so levied and collected for public school purposes, and that the appropriate County officials are directed to assess and collect said tax for such period and for such purpose.




