Know All Men by These Presents: That in consideration of **Three hundred forty one thousand and no/100 (\$341,000.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Donovan Builders, LLC** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Dustin W.
