KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 5th day of March, 2008, Telenia Henson Davidson and Kevin C. 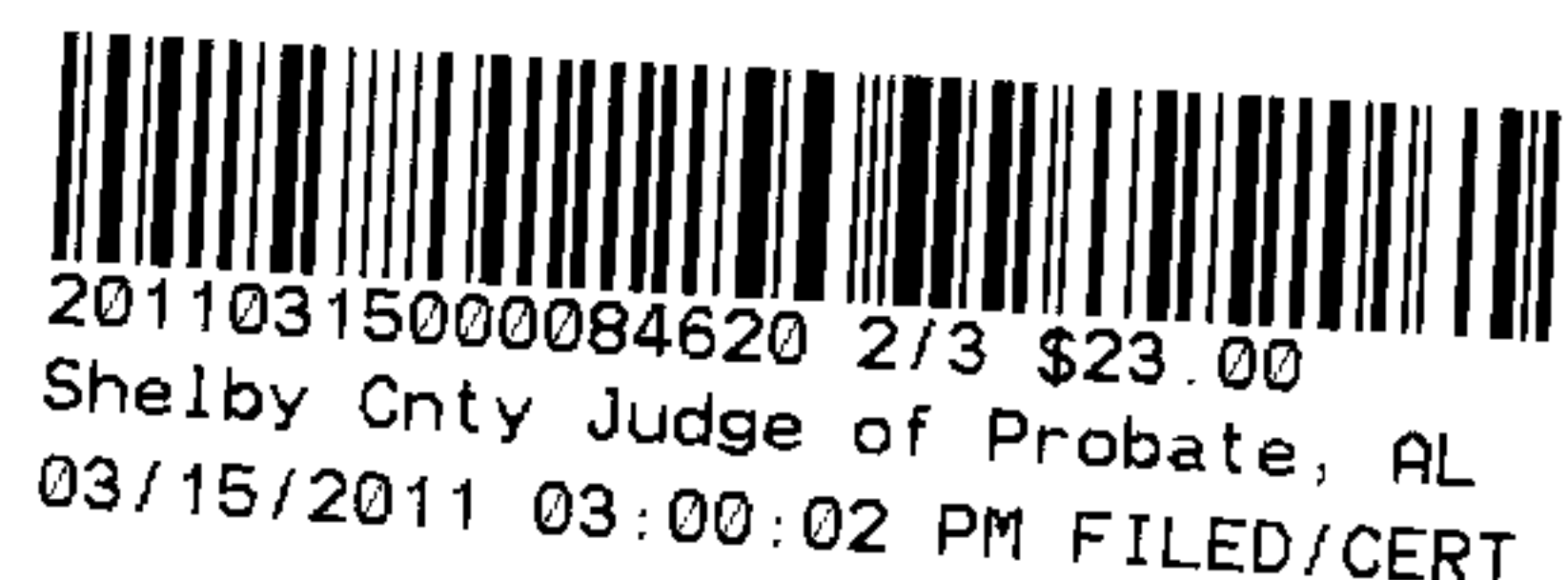

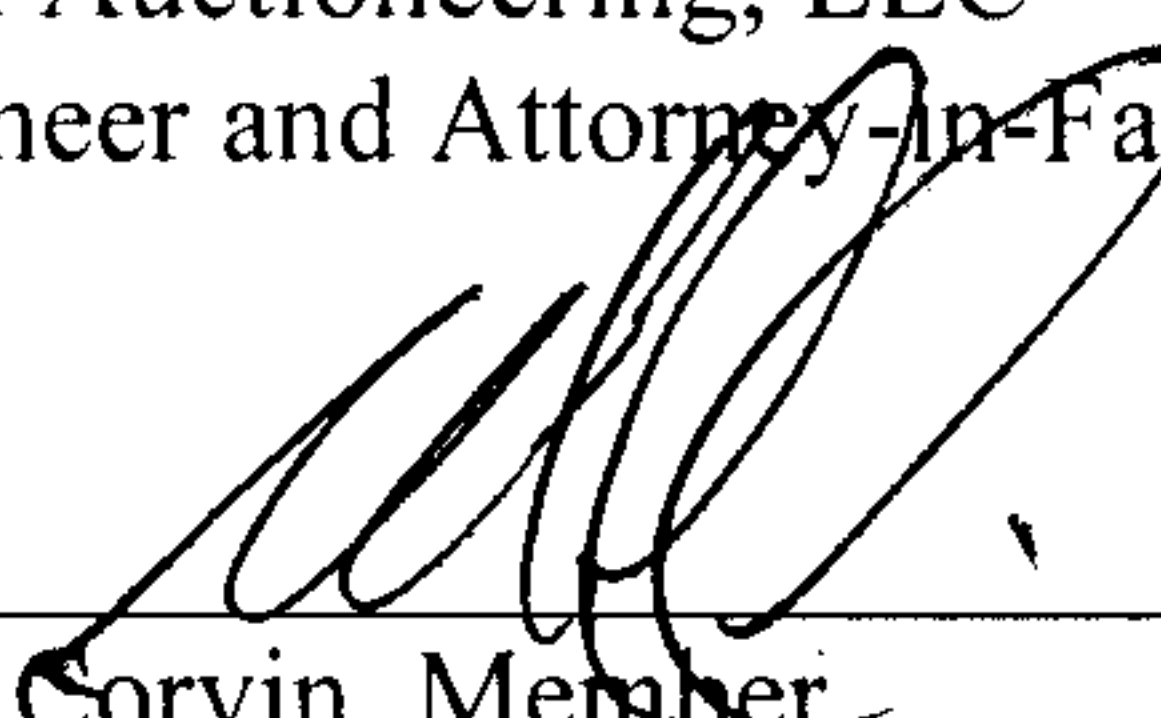
