FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 28th day of September, 2007, Clarence R. Moore, Jr., an unmarried man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Hometown Mortgage Services, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20071005000466150, said mortgage having subsequently been transferred and assigned to Flagstar Bank, F.S.B., by instrument recorded in Instrument No. 20101008000335260, in the aforesaid Probate Office ("Transferee"); and

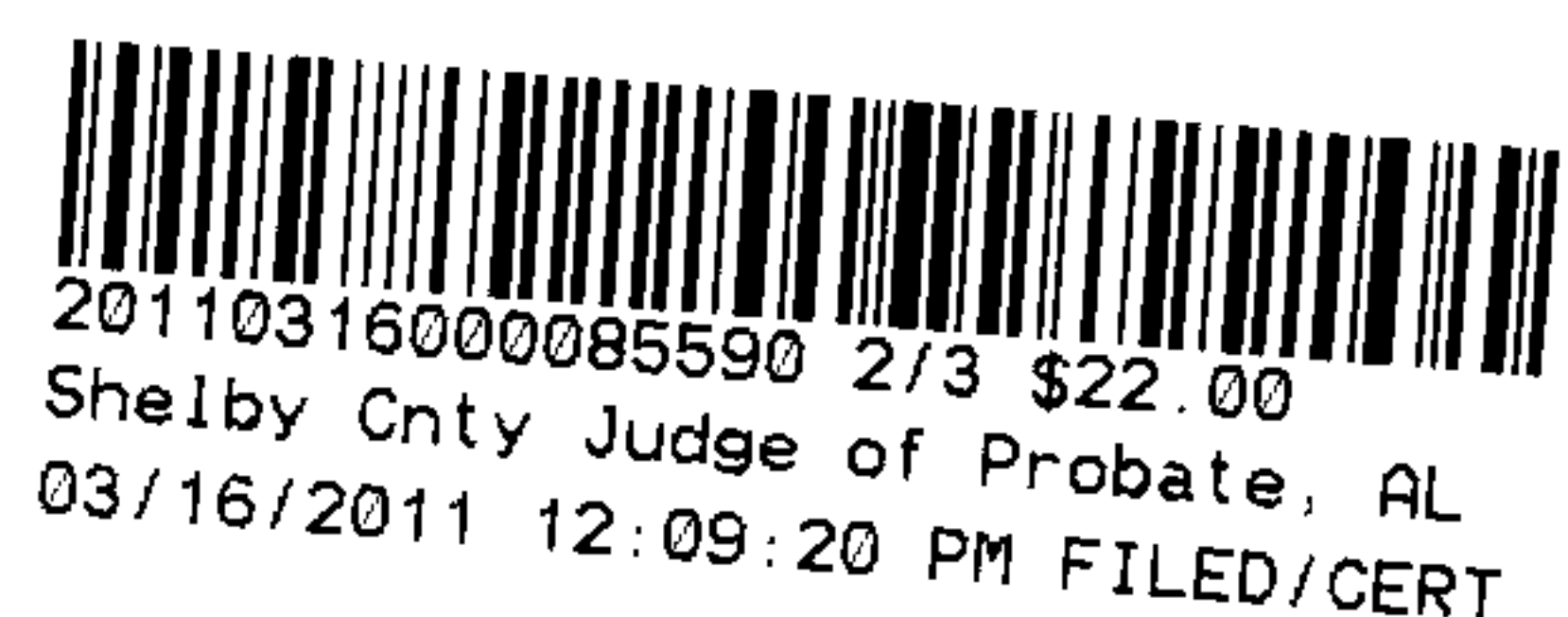


