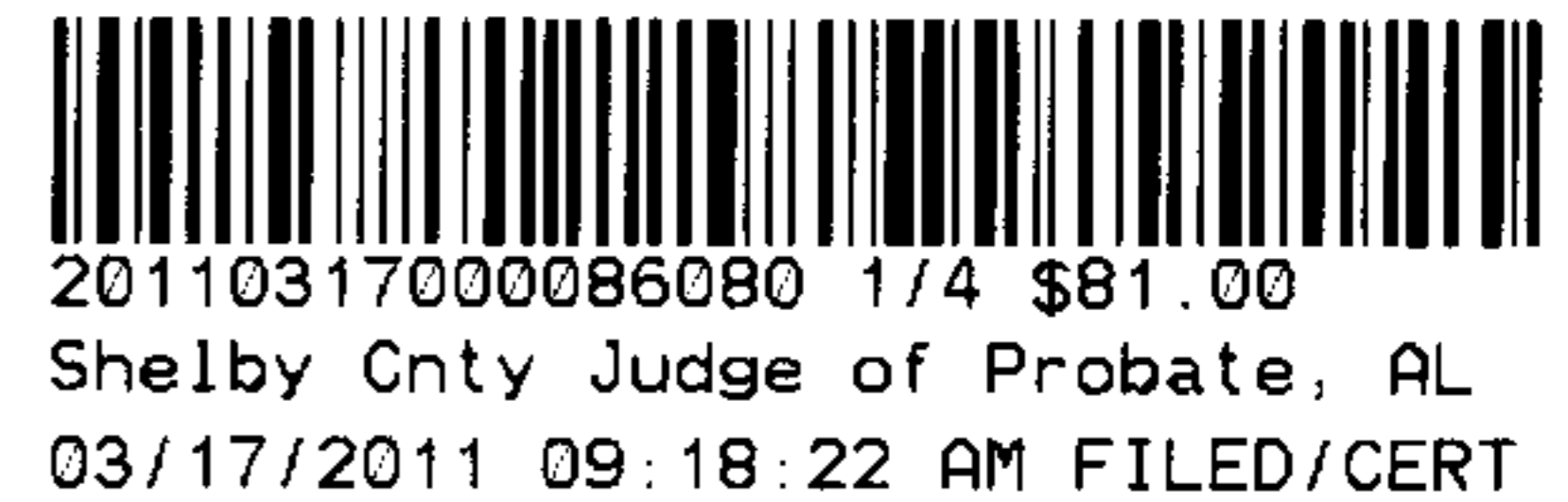


**SECOND AMENDED ARTICLES OF ORGANIZATION  
OF  
JEB AVIATION L.L.C.**

Pursuant to the Provisions of Act No 93-724 of the 1993 Alabama Legislature, the Under signed hereby adopt the following Amended Limited Liability Company Articles of Organization:

**ARTICLE I  
NAME**



The name of the limited liability company is:

**JEB AVIATION L.L.C.**

hereinafter referred to in these Articles of Organization as the “Company.”

**ARTICLE II  
DURATION**

The period of its duration is perpetual; provided however, that the Company shall cease to exist upon the winding up of its affairs and its dissolution in accordance with Section 37 of the Alabama Limited Liability Company Act (the “Act”).

**ARTICLE III  
PURPOSES**

The purpose for which the Company is organized is the transaction of any and all lawful business for which a limited liability company may be organized under the Act, including, without limitation, the following:

- a. To acquire. own. sell. exchange. mortgage. lease. operate. develop.

Company's business which may be legally exercised by limited liability companies under the Act or under the laws of any jurisdiction in which the Company may conduct its business.

- d. To engage in all activities necessary, customary, convenient, or incident to any of the foregoing.

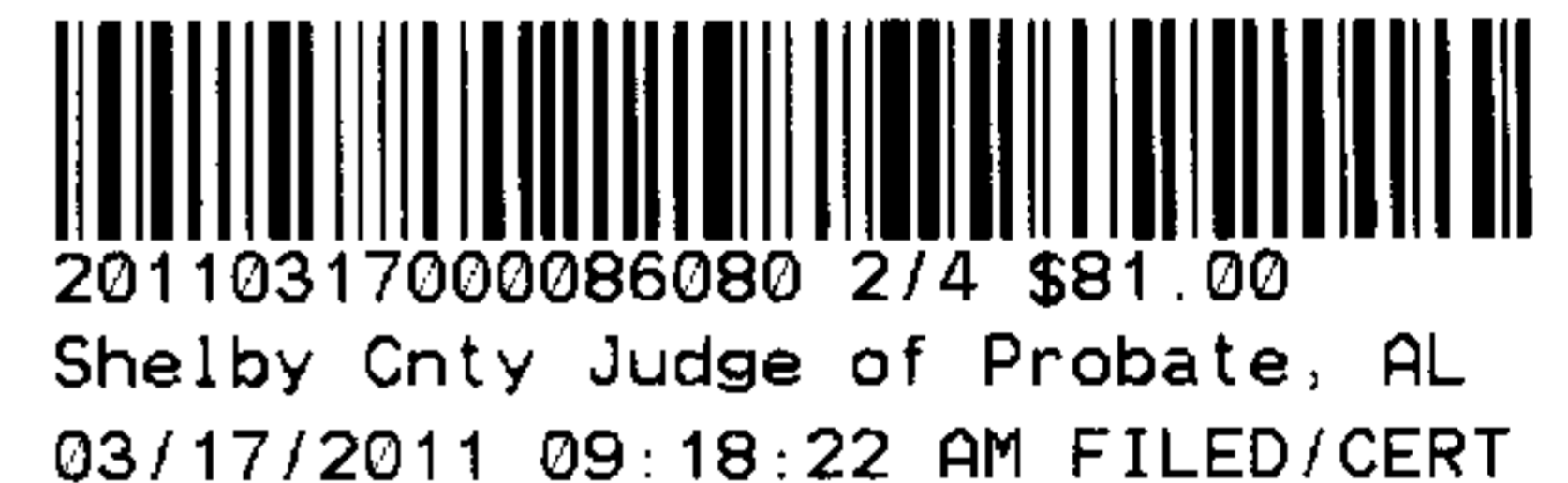

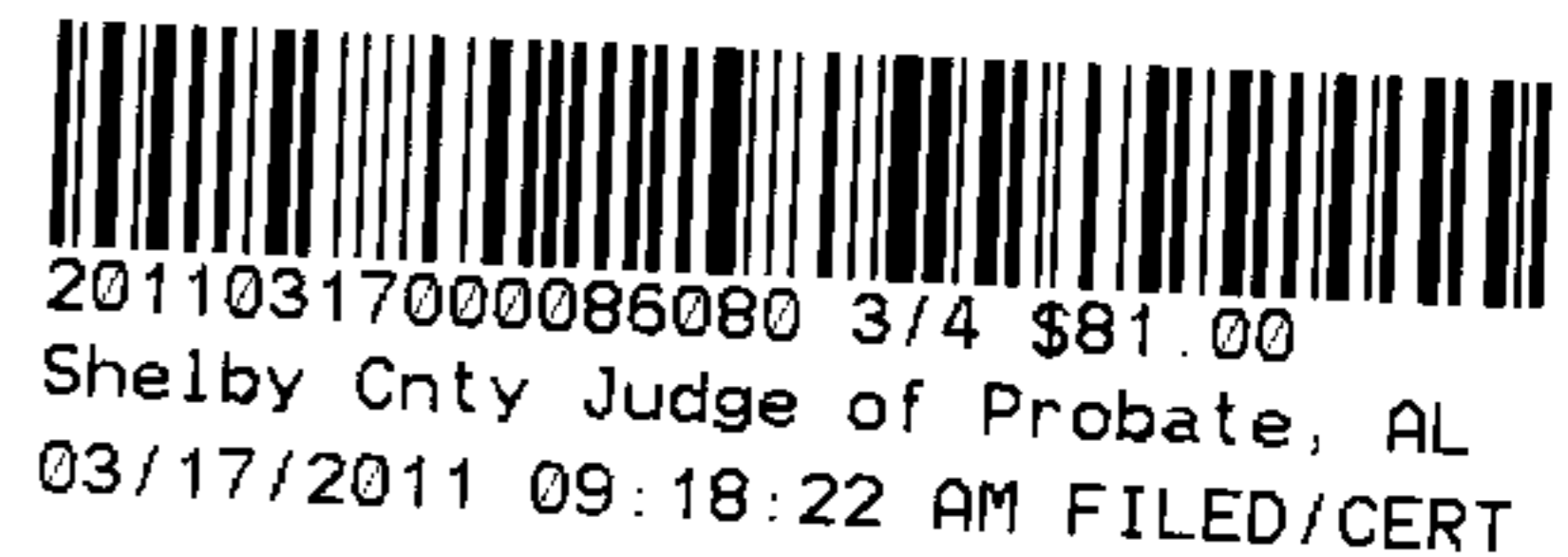
**ARTICLE VIII**

**OTHER PROVISIONS**

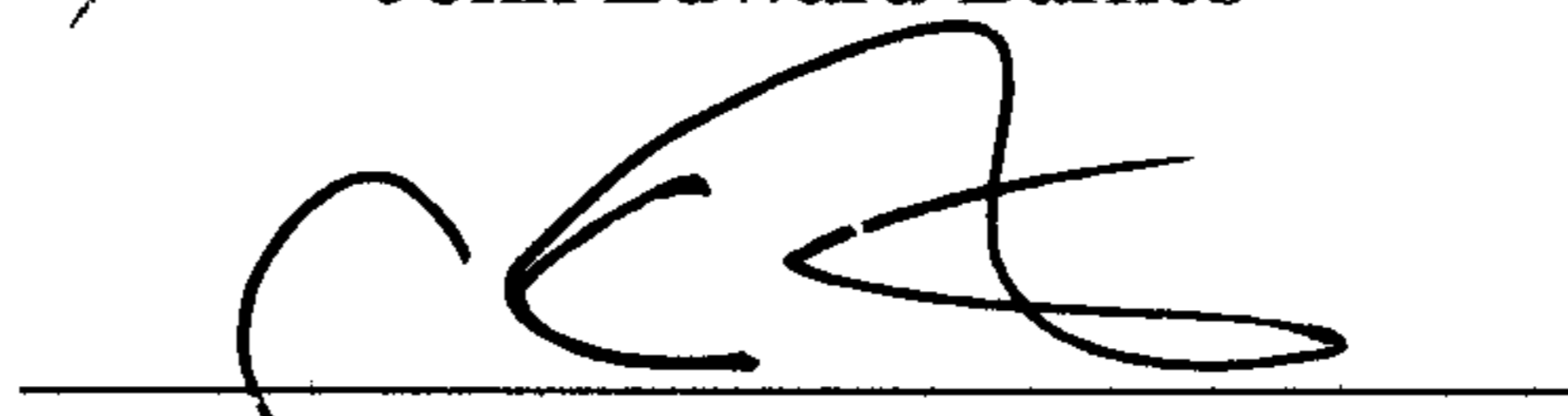


The ownership in the Limited Liability Company is to be allocated as follows:

<b>Chad E. Mathis</b>	<b>50%</b>

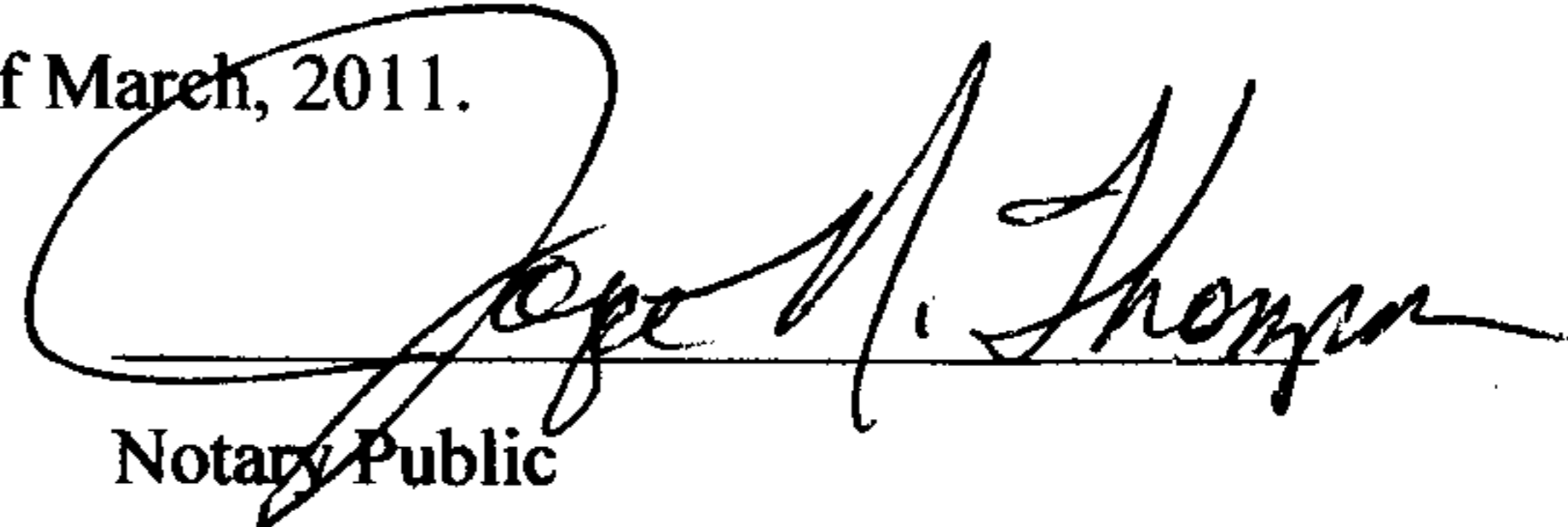

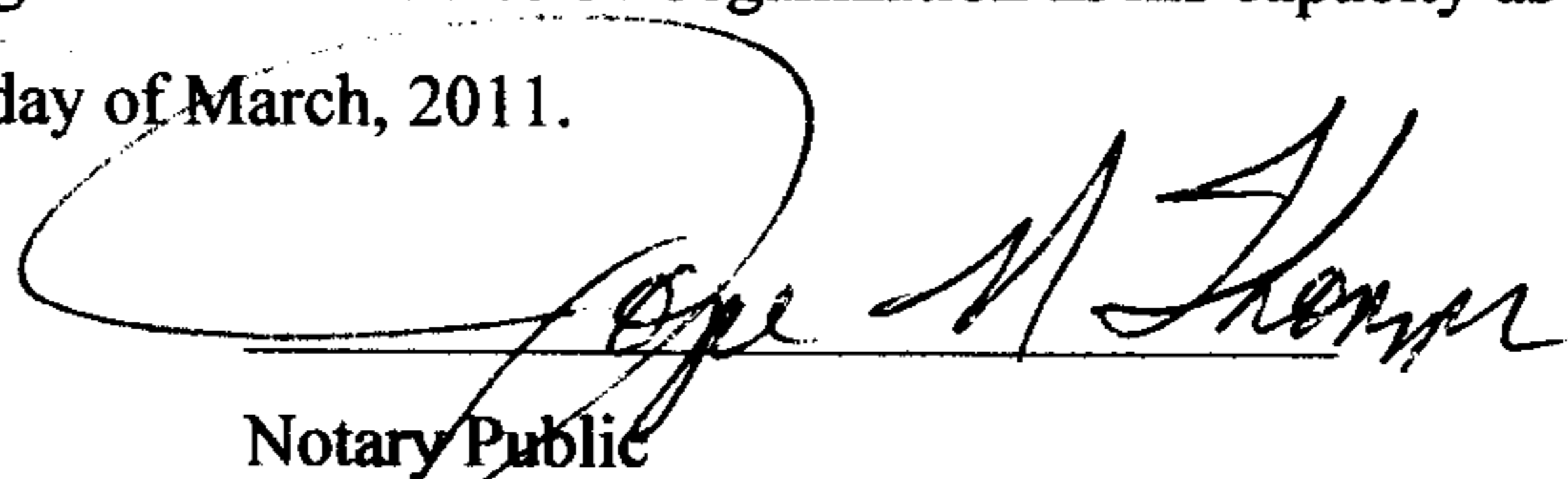
