FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 28th day of June, 2007, Karen Weems and Terry R. Weems, Wife and Husband, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Hometown Mortgage Services, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070705000315250, said mortgage having subsequently been transferred and assigned to Flagstar Bank, by instrument recorded in Instrument Number 20101210000415850, in the aforesaid Probate Office ("Transferee"); and

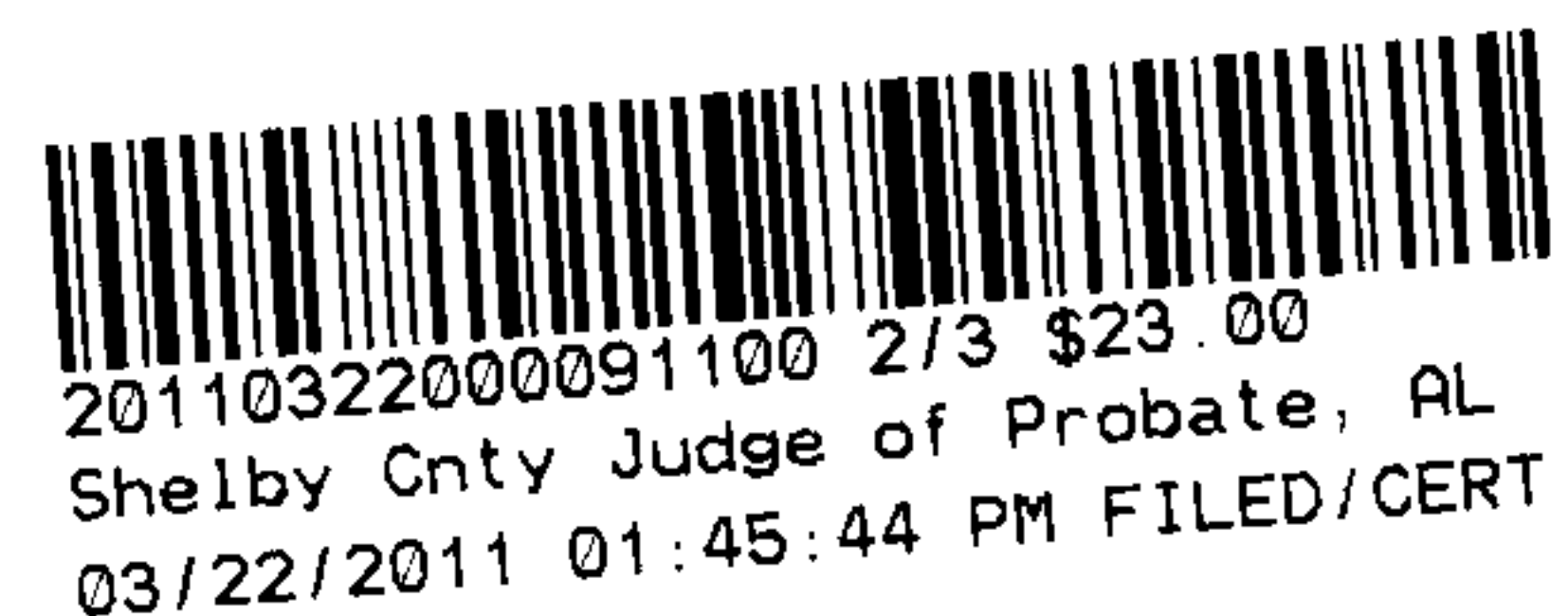


