

**ARTICLES OF ORGANIZATION OF  
CBMBWV Family LLC**

THE UNDERSIGNED, for the purpose of forming a limited liability company (the “Company”) pursuant to the provisions of the Alabama Limited Liability Company Act and any amendments thereto (hereinafter the “LLC Act”), does hereby adopt the following Articles of Organization:

**Article 1  
Name of Company**

The name of the limited liability company is CBMBWV Family LLC (hereafter “Company”).

**Article 2  
Period of Duration**

The existence of the Company shall commence on the date of the filing of these Articles of Organization in the office of the Judge of Probate of Shelby County, Alabama, and shall continue perpetually; provided, however, that the Company shall be dissolved prior to that date upon the earlier to occur of: (i) the written consent of all the members to dissolve the Company; (ii) as provided in the Operating Agreement; or (iii) as may be required under the LLC Act.

**Article 3  
Purpose**

The purpose for which the Company is formed is to own, maintain, manage, invest and otherwise operate assets otherwise owned directly or indirectly by certain trusts established by Jimmy D. Vernon for the benefit of some of his descendents, and any or all other lawful conduct for which a limited liability company may be organized.


**Article 4  
Registered Office and Registered Agent**

The location and mailing address of the initial registered office of the Company shall be 620 Lake Colony Pointe, Birmingham, Alabama 35242 and its registered agent at such address shall be Chris Vernon.



Any provision that is not inconsistent with the law for the regulation of the internal affairs of the Company is permitted to be set forth in the Operating Agreement of the Company.

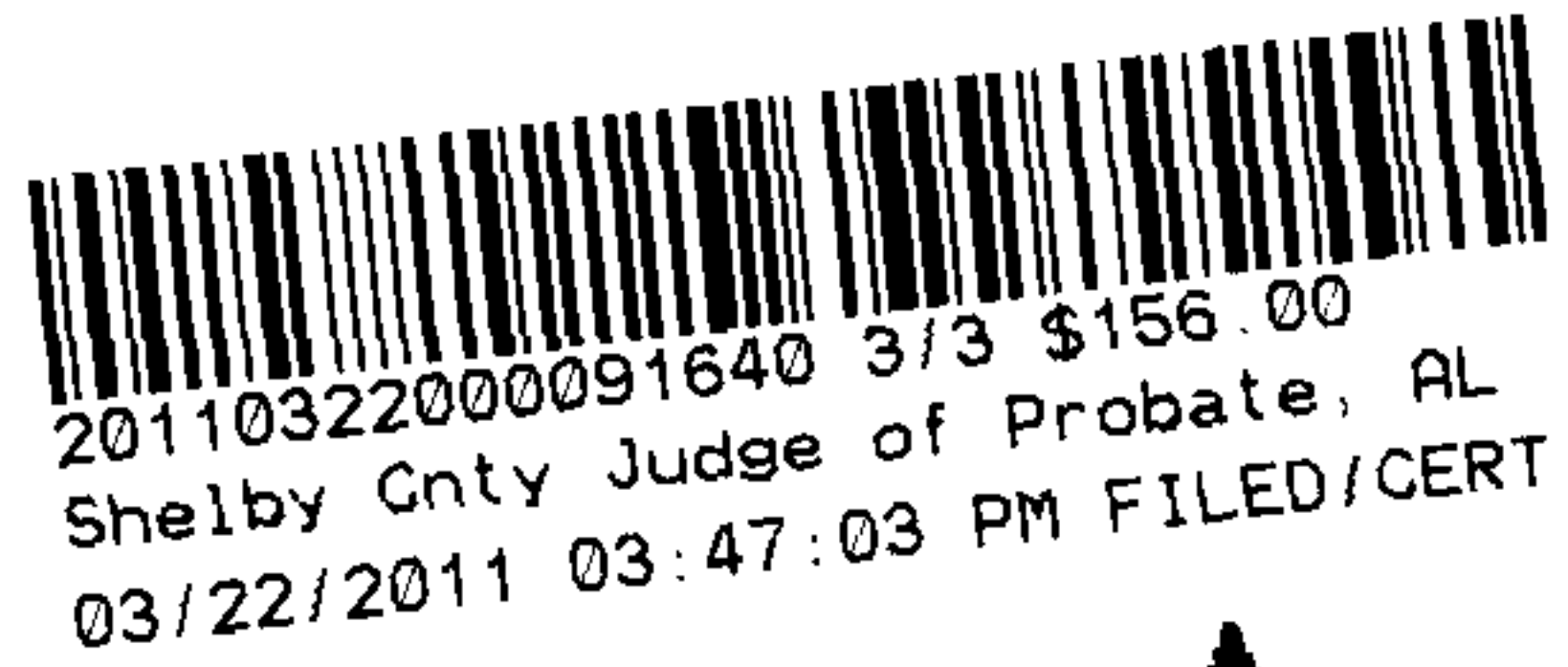
