

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on May 1, 2006, Michael Scott Rail and wife Brooke Rail, Party of the First Part, executed a certain mortgage to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for Lehman Brothers Bank, FSB, A Federal Savings Bank, its successors and assigns, party of the second part which said mortgage is recorded in Instrument No. 20060509000217350, in the Office of the Judge of Probate of Shelby County, Alabama Which said Mortgage was last sold, assigned and transferred to Federal National Mortgage Association; Instrument No. 20110203000038710
