ARTICLE II: PURPOSE



There is no other name given under heaven by which man must be saved. 3. The Holy Spirit inspired the writers of the Bible, convicts the world of sin, teaches us all things, and brings to our remembrance the Word of God. 



ORDER OF BUSINESS ADMINISTRATION

The Church and its purpose are the most important work on the face of the earth. This work of ministry must operate effectively and efficiently so that our Lord will be pleased in a work that is "well done by good and faithful servants." The church must internally have its house in order. If we proclaim from the pulpit this truth from scripture to our people, we must then be the pacesetters in demonstrating how our business and financial matters are handled.

When a church is not properly organized and operating effectively, you will typically find inefficiency, inconsistency, lack of accountability, misunderstanding of responsibilities and authority levels, confusion regarding policy making, inadequate internal controls over operations, management by exceptions, unethical business practices, and legal and financial exposures. If the church leaders fill deficiency and inadequate in church management, they should seek out wise counsel in those areas of concern. As Proverbs 1:5 states "Let the wise listen and add to their learning and let the discerning get guidance." Wise counsel will convert concerns, doubts and uncertainties into a sense of peace and a higher level of confidence in ministering for the Lord.

- It is the custom of Jesus Temple Church to hold a business meeting quarterly to discuss any and all transactions which transpired for the previous quarter.
- All manner of business should be taken care with consent of ALL appointed leaders.
 Not at any given time is any leader to take it upon themselves to mandate any financial decision without the consent of ALL leaders involved.
- The Leader is to appoint a church member to participate in assisting the church clerk when handling all business transactions. NOONE else is allowed in the office during the time of business transactions.
