KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 23rd day of February, 2007, Robert Lee Smith Jr. and Terra L. Smith, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. solely as nominee for New South Federal Savings Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070228000090220, said mortgage having subsequently been transferred and assigned to EverBank, by instrument recorded in Instrument No. 20110217000056240, in the aforesaid Probate Office ("Transferee"); and

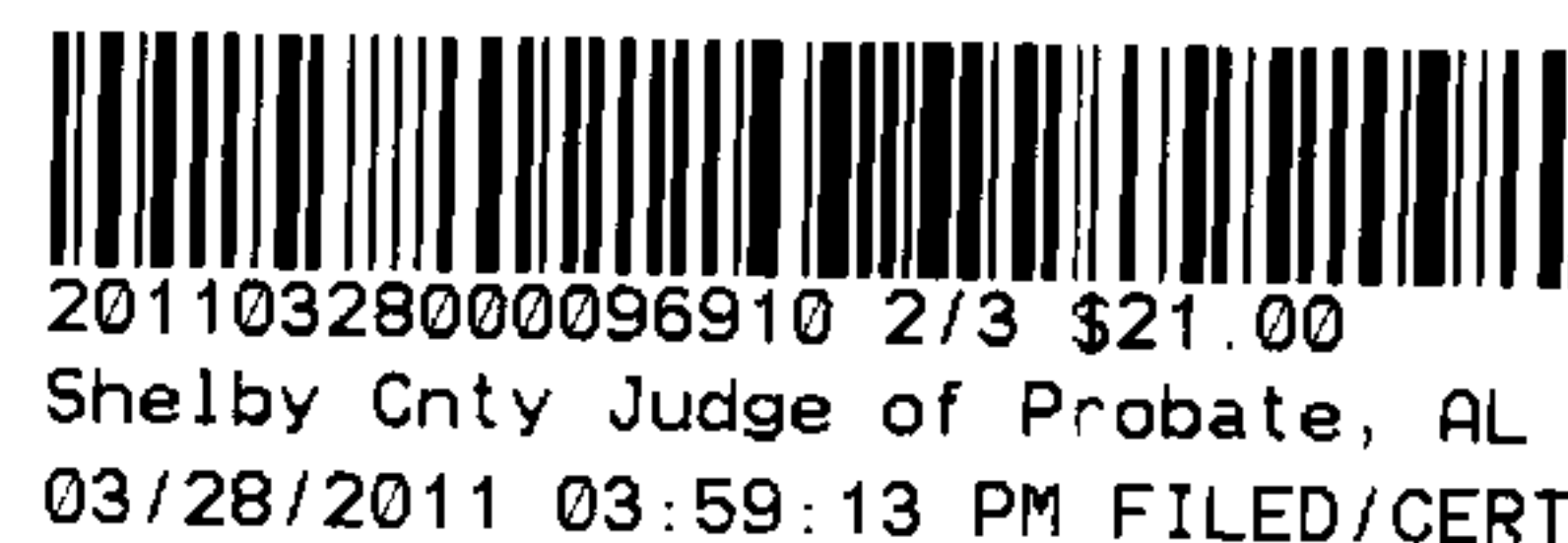

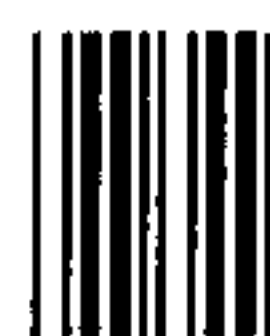
