That said Association claims a lien upon property owned by Manuel Sandoval Huerta situated in Shelby County, Alabama, described as follows:


Lot 473, according to the Survey of Weatherly Treymoor Abbey,

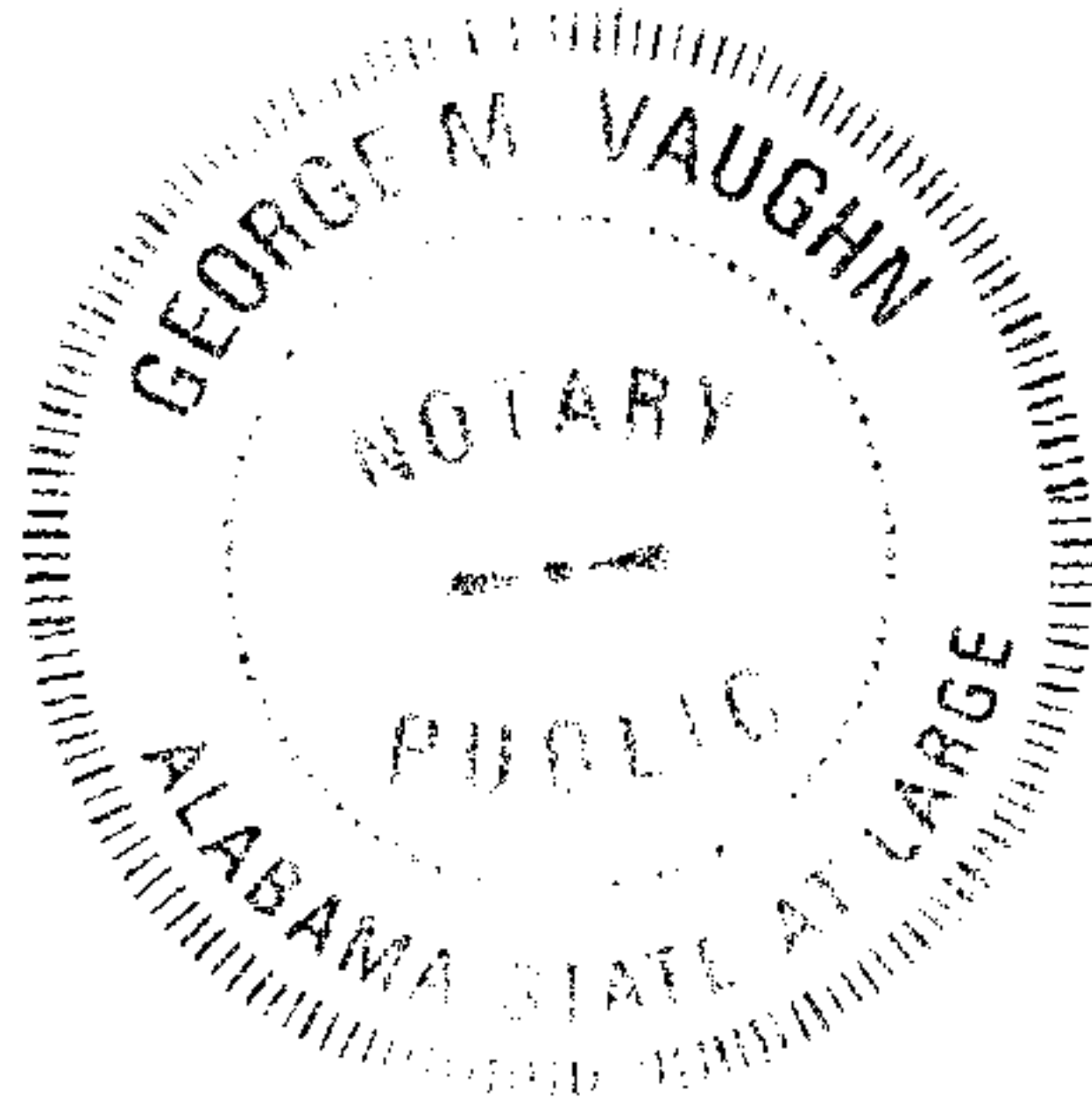


