ARTICLES OF ORGANIZATION

OF

FlowerArt Designs, LLC

1. The name of the limited liability company is **FlowerArt Designs, LLC**.
2. The limited liability company will have perpetual existence.
3. The purpose of the LLC is to organize a florist business, which shall include, but not be limited to, the retail sale of flowers and floral arrangements.
