Pursuant to the provisions of Section 10-12-11 of the Code of Alabama (1975), as amended, the undersigned limited liability company hereby adopts the following Articles of Amendment to its Articles of Organization.

1. The name of the limited liability company is GLAW LLC (the "Company").
2. The Articles of Organization of the Company were filed with the Office of the Judge of Probate of Shelby County, Alabama on February 14, 2011.
3. The amendments to the Articles of Organization set forth herein were adopted by the Company in the manner prescribed by the Alabama Limited Liability Company Act.
4. The Articles of Organization are hereby amended by deleting the provisions of Section 1 thereof and inserting in lieu thereof the new Section 1:

1. The name of the limited liability company is Gibbons Graham LLC (hereinafter referred to in these Articles of Organization as the "Company").

5. The Articles of Organization are hereby amended by deleting the provisions of Sections 4, 5 and 6 thereof and inserting in lieu thereof the following new Sections 4, 5 and 6, respectively:

4. The location and mailing address of the registered office of the Company is 100 Corporate Drive, Suite 125, Birmingham, Alabama 35242. The name of its registered agent at that address is Ray D. Gibbons.

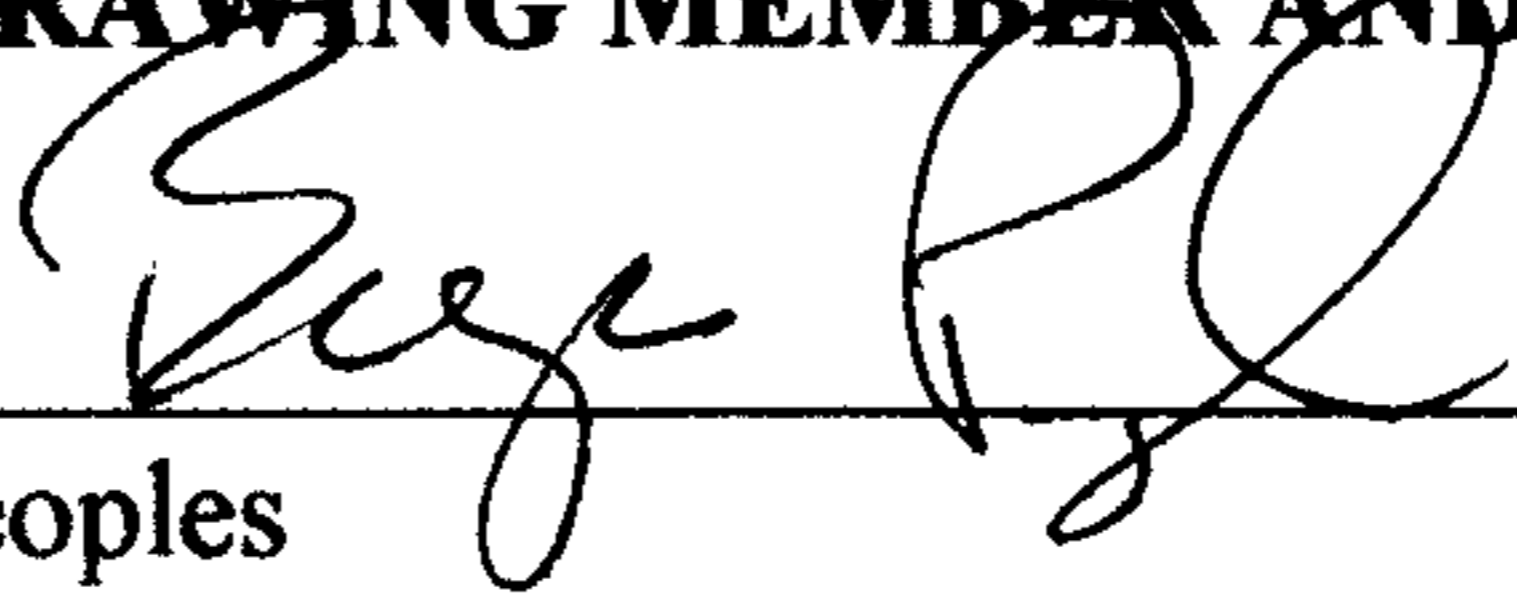

6. This Amendment was adopted as of March 1, 2011.

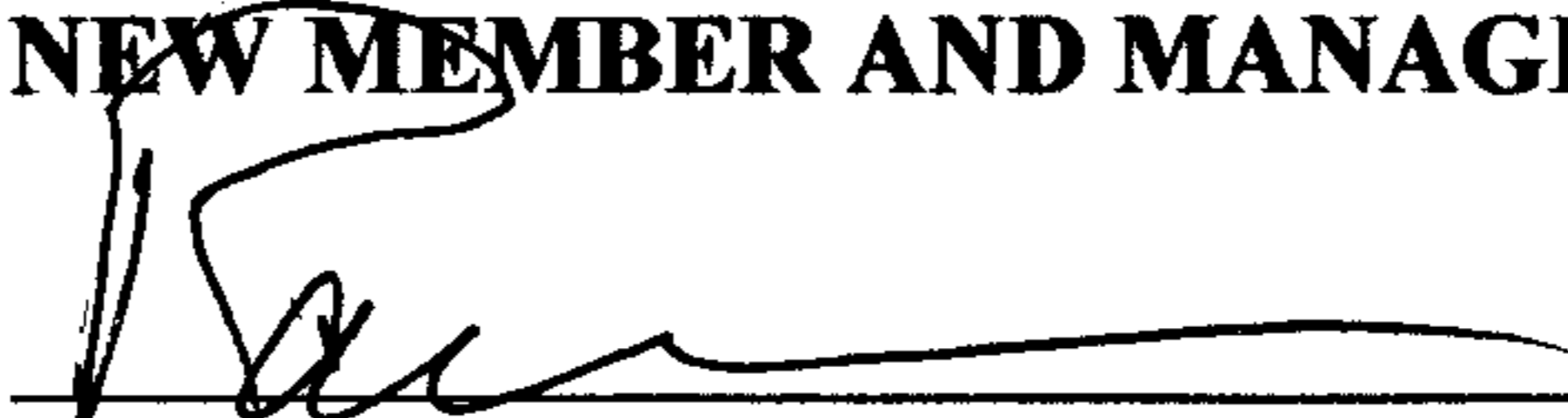
