FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 11th day of December, 2001, William F. Dial, Jr. and Rebecca E. Dial, husband and wife, executed that certain mortgage on real property hereinafter described to Ameriquest Mortgage Company, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 2001-56826, said mortgage having subsequently been transferred and assigned to Chase Home Finance LLC, by instrument recorded in Instrument # 20101028000360820, in the aforesaid Probate Office ("Transferee"); and


