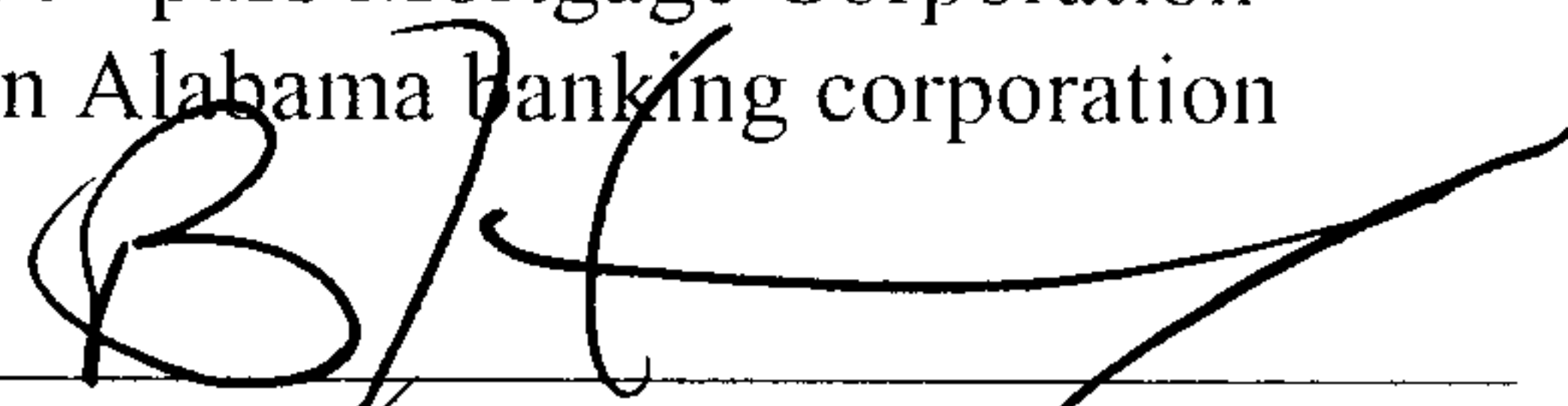
EXHIBIT A
