Commence at the Southeast corner of the Northwest one-fourth of the Northwest one-fourth of Section 22, Township 21 South, Range 3 West, Shelby County, Alabama; thence proceed North 00° East for a distance of 138.48 feet; thence proceed South 90° West for a distance of 150.00 feet to a 1" pipe in place; thence continue South 90° West for a distance of 134.76 feet to the point of beginning. From this beginning point turn a 90° angle to the right and proceed North for a distance of 7.5 feet; thence turn a 90° angle to the left and proceed West for a distance of 40.40 feet; thence turn a 90° angle to the left and proceed East for a distance for 40.40 feet to the point of beginning.
