**WARRANTY DEED**

**KNOW ALL MEN BY THESE PRESENTS**, That in consideration of the sum of **Three Hundred Ninety Thousand dollars and Zero cents ( \$390,000.00 )** paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, **Ronald Reese and wife, Kimberly Reese** (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto **Joshua L. Patrick and Kelly B. Patrick as joint tenants with rights of survivorship** (hereinafter Grantees), all of my/our right, title and interest in the following described real estate, situated in **Shelby County, Alabama**:

Lot 328, according to the survey of Brook Highland, 7<sup>th</sup> Sector, as recorded in Map Book 13, page 99 A & B, in the probate office of Shelby County, Alabama.


