FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 26th day of June, 2008, Karren F. Rogers, married, and Jemal Rogers, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. solely as nominee for IndyMac Bank, F.S.B., a federally chartered savings bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20080710000278830, said mortgage having subsequently been transferred and assigned to OneWest Bank, FSB, by instrument recorded in Instrument No. 2011032500095650, in the aforesaid Probate Office ("Transferee"); and

WHEREAS, on April 26, 2011, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly conducted, and OneWest Bank, FSB did offer for sale and sell at public outcry in front of the Courthouse door in Columbiana, Shelby County, Alabama, the property hereinafter described; and


