Articles of Incorporation

Article I The name of the corporation: Center for Spiritual Living Metro Birmingham

Article II The duration of the corporation is perpetual

Article III The Corporation has been organized for the following purposes:

This corporation is a religious corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Corporation Act of the State of Alabama primarily for religious purposes.

This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

Notwithstanding any other provision of these Articles, this corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(c) of the Internal Revenue Code, or (b) by a corporation described in Section 170(c)(2) of the Internal Revenue Code and applicable state law.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate or intervene in any political campaign (including the publishing or distributing of statements) on behalf of any candidate for public office.

Article IV Membership and classes of membership shall be determined and controlled by the by-laws of the Corporation.
