WHEREAS, heretofore, on to-wit: March 20, 1996 Gerald R. Atchley, a married man, mortgagor, executed a certain mortgage to First Federal Bank, a Federal Savings Bank, said mortgage being recorded in **Instrument No. 1996-09117**, in the Probate Office of Shelby County, Alabama; and


